RESOLUTION NO. LNT-22-11

AUTHORIZING THE APPROPRIATION OF LANDS FROM PENNSYL-VANIA INTERNATIONAL RACEWAY, INC., FOR A TWENTY-FIVE (25') FOOT WIDE DRAINAGE AND UTILITY EASEMENT AND AUTHORIZING THE FILING OF A DECLARATION OF TAKING AND ALL NECESSARY ACTION FOR THE ACQUISITION THEREOF.

WHEREAS, the Board of Supervisors of Lower Nazareth Township, pursuant to authority granted it under The Second Class Township Code, Act of May 1, 1933, P.L. 103, No. 69, Section 101, et seq., as reenacted and amended, and The Eminent Domain Code, Act of June 22, 1964, Special Session, P.L. 84, Article I, Section 101, et seq., contemplates the construction of stormwater drainage facilities as hereinafter described; and

WHEREAS, in order to carry out the construction of stormwater drainage facilities, underground and/or aboveground, it is necessary that the Township acquire a drainage and utility easement on lands owned by Pennsylvania International Raceway, Inc., as hereinafter described; and

WHEREAS, pursuant to the authority granted it under the aforementioned statutes, Lower Nazareth Township is authorized to acquire the drainage and utility easement through eminent domain proceedings.

NOW, THEREFORE, be it resolved, that the Township of Lower Nazareth, Northampton County, Pennsylvania, in accordance with authority conferred by law, selects and appropriates for the purposes of stormwater drainage facilities the following property:

All that certain tract or parcel of land more particularly described in Exhibit "A", attached hereto, and made a part hereof, being description of land, drainage and utility easement, to be acquired from Pennsylvania International Raceway, Inc., for stormwater drainage facilities, specifically the securing of an easement for the construction of stormwater drainage facilities, containing a calculated area of 17,506 square feet or 0.402 acres of land more or less and being part of property identified as Northampton County Tax Parcel No. K7-17-9, more particularly described in the Office for the Recording of Deeds in and for Northampton County in Deed Book Volume 2000-1, Page 021059.

RESOLVED, that the title to be acquired shall be a drainage and utility easement.

RESOLVED, that the Lower Nazareth Township Solicitor and its proper Officers are hereby authorized to file a Declaration of Taking and such other proceedings as may be necessary or desirable to carry out the purpose of this Resolution.

RESOLVED, that the institution of such proceedings, and any damages which may be agreed upon or awarded to any party in interest, including the owner of said property, and located within the area shall be paid out of the funds of Lower Nazareth Township.


