RESOLUTION NO. 2013- LNT-15-13**

WHEREAS, the Board of Supervisors of the Township of Lower Nazareth, Northampton County, Pennsylvania, contemplate the establishment of an Agricultural Security Area and in accordance with the Agricultural Area Security Law, Act No. 43 of 1981; and

WHEREAS, the Board of Supervisors of Lower Nazareth Township have received proposals from the attached List of Property Owners indicating their desire to be included in the Area; and

WHEREAS, the Board of Supervisors of Lower Nazareth Township have received a favorable report of acceptable from the Lower Nazareth Township Planning Commission; and

WHEREAS, the Board of Supervisors of Lower Nazareth Township have established and formed an Agricultural Area Advisory Commission who report favorable acceptance of the proposal.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Supervisors of Lower Nazareth Township, as follows:

SECTION 1: The Board of Supervisors of Lower Nazareth Township declare and accept the proposed Agricultural Security Area for Lower Nazareth Township.

SECTION 2: The Agricultural Security Area shall be comprised of the property designated on the attached Listing of Agricultural Security Area Properties.

SECTION 3: This Resolution including the Listing of Agricultural Security Properties shall be recorded in the Office for the Recording of Deeds in and for Northampton County pursuant to the Agricultural Security Law.
