Agenda Amendment and Approval

Solicitor Asteak requested to add Easton Eastgate Popeyes Improvements Agreement under his reports. Supervisor Brown made a motion to approve the amended agenda. Supervisor Teague seconded. Motion passed.

Approval of Minutes

The meeting minutes of February 14th were submitted for review and approval. Supervisor Brown made a motion to approve the minutes as presented. Vice Chairman Boucher seconded. Motion passed.

The meeting minutes of February 15th were submitted for review and approval. Supervisor Teague made a motion to approve the minutes as presented. Supervisor Brown seconded. Motion passed. Vice Chairman Boucher abstained as he was not present for the meeting.

Reports

Supervisor's Comments

Open Space Preservation Supervisor Brown stated the EAC is set to meet March 11th.

Parks and Recreation – Supervisor Templeton provided updates:

- Summer Park Program we have staff in place to run program

Subdivision and Land Development

There was nothing under Subdivision and Land Development.

Solicitor's Report

<u>DelSerro Conservation Easement – Agreement of Sale</u> – Solicitor Asteak indicated that we have been working with Mr. DelSerro for a long period of time and have finally reached an agreement to acquire 22.159 acres of land for \$262,365. Mr. DelSerro has executed an agreement for the Township to acquire the conservation easement using EIT Open Tax funds. Chairman Pennington pointed out that the Township is not buying the land, only the development rights so the land can never be developed.

Resolution LNT-16-24: Supervisor Templeton made a motion to approve Resolution #LNT-16-24. Supervisor Brown seconded. Motion passed.

Agreement of Sale: Supervisor Teague made a motion to execute the agreement of sale. Supervisor Brown seconded. Motion passed.

StoneBriar II Zoning Map Amendment – Solicitor Asteak asked for authorization to forward the zoning map amendment to our Planning Commission and the Lehigh Valley Planning Commission for comments. Supervisor Teague made a motion to forward the zoning map amendment for comments. Supervisor Templeton seconded. Motion passed.

Zoning Ordinance Amendment – Mineral Extraction – Solicitor Asteak reported that this amendment was generated as result of comments/concerns from Heidelberg. After lengthy negotiations, an agreement has been reached. Solicitor Asteak asked for authorization to forward the amendment to our Planning Commission and the Lehigh Valley Planning Commission for comments. Supervisor Templeton made a motion to forward the amendment for comments. Vice Chairman Boucher seconded. Motion passed.

<u>Zoning Ordinance Amendment – Minor Revisions</u> – Previously Ms. Stauffer noted that some issues have come to Ms. Seese's attention. EPD and Solicitor Asteak have drafted an ordinance for text amendments and Solicitor Asteak asked for authorization to forward to our Planning Commission and the Lehigh Valley Planning Commission for comments. Supervisor Teague made a motion to forward the ordinance for comments. Vice Chairman Boucher seconded. Motion passed.

<u>Keystone Consulting Engineers</u> – Chairman Pennington indicated that we have not resolved our issue with having our files returned. He recommended we take action of replevin if our files are not received within 20 days. Supervisor Teague made a motion to take action if our files are not returned. Supervisor Brown seconded. Motion passed.

<u>Easton Eastgate Land Development Improvements Agreement</u> – Supervisor Templeton made a motion to authorize execution of the agreement upon receipt of the letter of credit. Vice Chairman Boucher seconded. Motion passed.

Engineer's Report

February Report – Mr. Coyle reviewed his report for the month.

<u>Surrey Glen Walking Trail – Bid Results</u> – Mr. Coyle reviewed his letter dated February 27th, noting that four (4) bids were received and recommended the bid be awarded to Gaver Industries for \$86,510.00. Supervisor Brown made a motion to award the project to Gaver Industries. Supervisor Teague seconded. Motion passed.

Manager's Report

<u>Avenu Payments Contract</u> – Ms. Stauffer noted that the is an online payment system that will support our online permit processing. We will also be able to take and receipt payments in the office. The only cost to the Township is the credit card processing device and annual maintenance fee. Supervisor Templeton made a motion to contract with Avenu Payments. Supervisor Teague seconded. Motion passed.

<u>Fuel Escalator Clause Resolution LNT-17-24</u> – Ms. Stauffer noted that this helps with bidding, assuring the contractor the ability to put in for price increase, if needed. Supervisor Brown made a motion for approve Resolution #LNT-17-24. Supervisor Templeton seconded. Motion passed.

Ms. Stauffer was not looking for a motion, only for direction. Nazaeth Area Baseball and Softball have requested to use our fields August $12^{th} - 15^{th}$ for a summer park program. She shared the request with the recreation committee this evening and they were not opposed to the use and at no cost. Supervisor Brown noted we would just lump that use in with their normal fall use of fields. The was not opposed.

A motion was moved by Vice Chairman Boucher to pay the bills as presented. Supervisor Templeton seconded. Motion passed.
