## LOWER NAZARETH TOWNSHIP BOARD OF SUPERVISORS MINUTES

February 12, 2025

The Lower Nazareth Township Board of Supervisors held a public meeting on Wednesday, February 12, 2025, Chairman Pennington called the meeting to order at 7:09PM.

#### Agenda Amendment and Approval

Ms. Stauffer requested to add the Agricultural Security Committee appointment under Supervisor's Comments. Vice-Chairman Boucher made a motion to approve the amended agenda. Supervisor Teague seconded. Motion passed.

### **Approval of Minutes**

The meeting minutes of January 22<sup>nd</sup> were submitted for review and approval. Supervisor Teague made a motion to approve the minutes as presented. Supervisor Brown seconded. Chairman Pennington abstained. Motion passed.

#### Reports

No reports.

#### **Supervisor's Comments**

<u>Open Space Preservation</u> – Supervisor Brown reported that the EAC met on Monday and continues to review the various properties on the Township's official map to prioritize which properties would be most ideal for development rights acquisition.

<u>Parks and Recreation</u> – Supervisor Brown noted upcoming events including the Egg Hunt, Dogs Day Out, and the Tree Lighting. He commented that the priority for Public Works following a storm is keeping the roads clear; not the parks; one the paths melt parks will reopen.

Library News – Supervisor Teague had nothing to report.

<u>CRPC</u> – Vice-Chairman Boucher provided a report for incidents for 2024; 9,168 total incidents with 46% of those incidents occurring in Lower Nazareth.

Board of Supervisors Minutes February 12, 2025 <u>Agricultural Security Committee</u> – An email of interest was received from Joan Garrett. Vice-Chairman Boucher made a motion to appoint Joan Garrett to the Ag Security Committee. Supervisor Brown seconded. Motion passed.

#### **Subdivision and Land Development**

<u>Hecktown Road Business Park – Lot 6 & 7 – Kervan Properties LLC</u> – Solicitor Asteak discussed the progress.

Improvements Agreement & Project Security - Received

Intermunicipal Agreement - Between Bethlehem Township and Lower Nazareth will be before Bethlehem Township for approval at their meeting next week.

Supervisor Teague made a motion to authorize to execute the agreements and record the plan based on Bethlehem's approval of intermunicipal agreement. Vice-Chairman Boucher seconded. Motion passed.

#### Solicitor's Report

<u>Kay-Trio Letters of Credit Notice of Non-Renewal</u> – On January 2<sup>nd</sup> the Township received notice from BanCorp that they will not be renewing the numerous letters of credit issued for the Fields at Trio Farms project. The letters of credit expire on different dates through 2025.

Solicitor Asteak provided an update. The developer and engineer have been working with our engineer. Engineer Coyle reported they have had constant contact with Kay, improvements are being made, however they are limited due to weather. A construction schedule has been made to meet timeline.

Solicitor Ateak tabled action and said we will revisit at the second meeting in March. We need to be satisfied with the progress by April or we will pull the LOC. Solicitor Ateak will communicate this to Attorney Preston and Engineer Coyle can let Kay know.

<u>David Steckel – Human Resource Attorney</u> – Solicitor Asteak explained the situation. There is no conflict of interest as Attorney Steckel is solely for employment issues. The Board was satisfied, and Supervisor Teague made a motion to affirm the appointment. Supervisor Brown seconded. Motion passed.

#### **Engineer's Report**

<u>LVTC III – Letter of Credit Reduction and Commence Maintenance</u> – Engineer Coyle reviewed his January 27<sup>th</sup> letter recommending commencing the 18-month maintenance period. Vice-Chairman Boucher made a motion to commence the maintenance period. Supervisor Teague seconded. Solicitor Asteak noted that typically we use the Improvements Agreement through the maintenance period. Engineer Coyle has requested a new agreement for maintenance. Solicitor Asteak will forward the document to the developer for execution Motion passed.

#### Manager's Report

<u>2025 Road Projects – Authorization to Proceed and Advertise</u> – The 2025 road project is the mill and overlay of roads within Presidential Estates, as well as Frank and Delores. Supervisor Brown made a motion to authorize proceeding with the project and advertising. Vice-Chairman Boucher seconded. Motion passed.

<u>2025 Road Projects – Fuel Escalator Clause – Resolution #LNT-09-25</u> – Manager Stauffer noted this allows for price adjustments due to an increase in asphalt prices and helps keep bids lower. Vice-Chairman Boucher made a motion to approve Resolution #LNT-09-25. Supervisor Teague seconded. Motion passed.

<u>Time Extension Report</u> – Ms. Stauffer provided the report for time extensions accepted through today.

### Payment of the Bills

Supervisor Teague made a motion to pay the bills as presented. Vice-Chairman Boucher seconded. Motion passed.

#### Courtesy of the Floor

Sherri Bourneuf,4682 Stafford Avenue, requested to be placed on the agenda and provided with an explanation for the tax increase. As she was not present the matter was tabled.

Nancy Tammy, 4255 Beech Drive, thanked the Township for their efforts to keep Kay on task. She asked if the construction schedule could be made public as it would ease concerns to the residents. Engineer Coyle said he would share the schedule with staff and Manager Stauffer can share with the HOA. Ms. Tammy also noted that Kay is using the back property as a dumping ground and Engineer Coyle said he would look into that.

Pete Collins, 4255 Beech Drive, inquired when the maintenance period would begin. Engineer Coyle stated that all improvements are set to be completed by end of security.

Manager Stauffer shared an update on the Newburg Intersection Improvements. PADOT is currently projecting the project to commence in May 2026.
