## AGRICULTURAL SECURITY AREA APPLICATION

## Shannon/Miskelly, Tax Parcels #K7-17-18 0418 and #K7-17-18-0432

Present for the Application: Anton Shannon and Lisa Ann Miskelly

Solicitor Gary Asteak provided an overview of the submitted application and the Agricultural Security Area process. This property is located in both Lower Nazareth Township and Upper Nazareth Township.

Anton Shannon gave a brief summary about their farm and intentions for the land.

Hugh Harris inquired if anyone had examined the property to determine if the land meets the criteria. Robert Hoyer provided further explanation about the Agricultural Security Area process – this is the first step. That type of information will be further examined as they move along. Attorney Asteak stated entry of the parcel into the ASA will get recorded at the Northampton County Courthouse. Gary noted this also protects the property owner from nuisance claims.
