A RESOLUTION AUTHORIZING THE TOWNSHIP MANAGER TO MAKE APPLICATION TO THE MONROE COUNTY LOCAL SHARE ACCOUNT ON BEHALF OF LOWER NAZARETH TOWNSHIP FOR THE PURPOSE OF PROVIDING FUNDING FOR REPLACEMENT OF EIGHT GARAGE DOORS AT THE HECKTOWN VOLUNTEER FIRE COMPANY BUILDING

**WHEREAS**, Lower Nazareth Township is a community consisting of approximately eight square miles with a population of 6,922 people; and

**WHEREAS**, the Board of Supervisors of Lower Nazareth Township recognizes their responsibilities under the Second Class Township Code to provide for fire protection in the community; and

WHEREAS, Hecktown Volunteer Fire Company has been in operation since 1917; and

WHEREAS, Hecktown Volunteer Fire Company's building is reaching an age where certain repairs and maintenance are becoming necessary; and

**WHEREAS**, the eight overhead garage doors need to be replaced for the fire truck bays due to leaks and rusting.

**BE IT RESOLVED**, that the Lower Nazareth Township, Northampton County Pennsylvania hereby request a Monroe County Local Share Account grant of \$92,000 from the Commonwealth Financing Authority to be used for the purpose of replacing the eight garage doors at the Hecktown Volunteer Fire Company to keep their building in a state of good repair in an effort to continue providing a high level of excellence in fire protection for Lower Nazareth Township.

**BE IT FURTHER RESOLVED**, that the Applicant does hereby designate Lori A. Stauffer, Township Manager as the official to execute all documents and agreements between Lower Nazareth Township, Northampton County, Pennsylvania and the Commonwealth Financing Authority to facilitate and assist in obtaining the requested grant.
