**A RESOLUTION AUTHORIZING THE TOWNSHIP
MANAGER TO MAKE APPLICATION TO THE
STATEWIDE LOCAL SHARE ACCOUNT ON
BEHALF OF LOWER NAZARETH TOWNSHIP
FOR THE PURPOSE OF PROVIDING FUNDING
FOR A NEW ENGINE PUMPER TRUCK FOR THE
HECKTOWN VOLUNTEER FIRE COMPANY**

WHEREAS, Lower Nazareth Township is a community consisting of approximately eight square miles with a population of 6,922 people; and

WHEREAS, the Board of Supervisors of Lower Nazareth Township recognizes their responsibilities under the Second-Class Township Code to provide fire protection to the constituents of the Township to protect their health, safety, and welfare; and

WHEREAS, Hecktown Volunteer Fire Company has been in operation since 1917; and

WHEREAS, Hecktown Volunteer Fire Company's ability to provide fire protection to the community heavily relies upon properly functioning trucks and equipment; and

WHEREAS, the new truck will replace an existing truck that has reached its 20-year age limit.

WHEREAS, the National Fire Protection Association recommends replacement of fire trucks at 20-years as a common and practical benchmark to ensure community safety, compliance with standards, and operational efficiency.

BE IT RESOLVED, that Lower Nazareth Township, Northampton County Pennsylvania hereby requests a Statewide Local Share Account grant of \$1,000,000 from the Commonwealth Financing Authority to be used for the purpose of purchasing a new engine pumper truck for the Hecktown Volunteer Fire Department.

BE IT FURTHER RESOLVED, that the Applicant does hereby designates Lori A. Stauffer, Township Manager, as the official to execute all documents and agreements between Lower Nazareth Township, Northampton County, Pennsylvania and the Commonwealth Financing Authority to facilitate and assist in obtaining the requested grant.

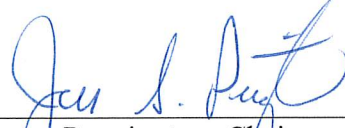

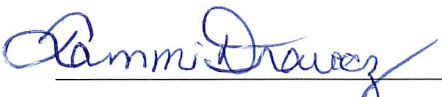
