**A RESOLUTION AUTHORIZING THE TOWNSHIP
MANAGER TO MAKE APPLICATION TO THE
STATEWIDE LOCAL SHARE ACCOUNT ON
BEHALF OF LOWER NAZARETH TOWNSHIP
FOR THE PURPOSE OF MAKING
IMPROVEMENTS TO THE TOWNSHIP
RECYCLING CENTER BUILDING.**

WHEREAS, Lower Nazareth Township is a community consisting of approximately eight square miles with a population of 6,922 people; and

WHEREAS, the Board of Supervisors of Lower Nazareth Township recognizes the importance of promoting recycling of yard waste under the Commonwealth of Pennsylvania laws; and

WHEREAS, Lower Nazareth Township has operated a yard waste facility for almost 20 years; and

WHEREAS, Lower Nazareth Township erected a pole building in 2019 for the purpose of storing equipment and constructing an office with a bathroom; and

WHEREAS, the building needs to be completed, including installation of utilities, pouring the concrete floor, construction of the office space and bathroom; however, funding shortages have prevented the completion of the building.

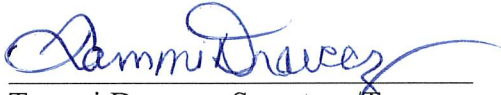
BE IT RESOLVED, that Lower Nazareth Township, Northampton County Pennsylvania hereby requests a Statewide Local Share Account grant of \$253,000, from the Commonwealth Financing Authority to be used for the purpose of making improvements to the Lower Nazareth Township recycling center building.

BE IT FURTHER RESOLVED, that the Applicant does hereby designates Lori A. Stauffer, Township Manager, as the official to execute all documents and agreements between Lower Nazareth Township, Northampton County, Pennsylvania and the Commonwealth Financing Authority to facilitate and assist in obtaining the requested grant.

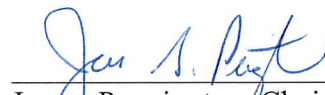

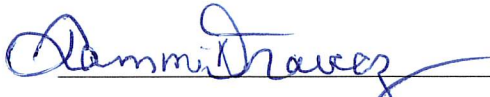
