**A RESOLUTION AUTHORIZING THE TOWNSHIP  
MANAGER TO MAKE APPLICATION TO THE  
GREENWAYS, TRAILS, AND RECREATION  
GRANT PROGRAM ON BEHALF OF LOWER  
NAZARETH TOWNSHIP FOR THE PURPOSE OF  
MAKING MUNICIPAL PARK IMPROVEMENTS  
TO HAHN'S MEADOW PARK.**

**WHEREAS**, Lower Nazareth Township is a community consisting of approximately eight square miles with a population of 6,922 people; and

**WHEREAS**, the Board of Supervisors of Lower Nazareth Township recognizes their responsibilities to provide their constituents with high-quality amenities in public parks for the recreation and enjoyment of the community; and

**WHEREAS**, the Township of Lower Nazareth has a total of five municipal parks including Hahn's Meadow Park; and

**WHEREAS**, It is the desire of the Lower Nazareth Township Board of Supervisors to expand the existing small parking lot and to create the first phase of a walking trail to meet their recreational duties and obligations to the public.

**BE IT RESOLVED**, that Lower Nazareth Township, Northampton County Pennsylvania hereby requests a Greenways, Trails, and Recreation grant of \$154,180 from the Commonwealth Financing Authority to be used for the purpose of making recreational improvements to Hahn's Meadow Park in Lower Nazareth Township and to further provide matching funds in the amount of \$35,455.


