**A RESOLUTION AUTHORIZING THE TOWNSHIP
MANAGER TO MAKE APPLICATION TO THE
GREENWAYS, TRAILS AND RECREATION
PROGRAM ON BEHALF OF LOWER NAZARETH
TOWNSHIP**

WHEREAS, Lower Nazareth Township owns a 90-acre parcel that is currently undeveloped; and

WHEREAS, the Board of Supervisors of Lower Nazareth Township desires to develop the property as a community park for the benefit and enjoyment of the community; and

WHEREAS, as part of the development of the community park, the Board of Supervisors of Lower Nazareth Township desires to create a community park that will be utilized by people of all ages and abilities; and

WHEREAS, one of the crucial basic amenities to be installed is an ADA-compliant bathroom facility;

WHEREAS, it is proposed that the ADA-compliant bathroom facility shall be positioned adjacent to the walking trail, which is partially funded by a grant through the Greenways, Trails and Recreation program;

BE IT RESOLVED, that the Lower Nazareth Township, Northampton County Pennsylvania hereby request a Greenways, Trails and Recreation Program (GTRP) grant of \$50,000.00 from the Commonwealth Financing Authority to be used for the purpose of installing a walking trail with nature education stations and a playground.

BE IT FURTHER RESOLVED, that the Applicant does hereby designate Lori A. Stauffer, Township Manager as the official to execute all documents and agreements between Lower Nazareth Township, Northampton County, Pennsylvania and the Commonwealth Financing Authority to facilitate and assist in obtaining the requested grant.
