#### Approval of Minutes

A motion was moved by Mr. Smalley to amend the January 7, 2019 meeting minutes to re-appoint Eric Nagle to the Vacancy Board. It was seconded by Mr. Hoyer. The motion carried. A motion was made to approve the amended minutes for January 7, 2019 meeting minutes by Mr. Boucher and seconded by Ms. Templeton. The motion carried

Mr. Pennington acknowledged the receipt of the Financial Report for December 2018, Zoning Administrator's Report for December 2018.

#### Correspondence

There was discussion under Correspondence.

#### **Subdivision and Land Development**

<u>Hecktown Road Business Park – Lots 6 & 7 – Preliminary Land Development</u> – Mr. Piperato stated that Hecktown Road BP was looking for approval for the Preliminary Land Development and that they were agreeable to terms in Mr. Kortze's letter and had no problem with entering into an inter-municipal agreement between the two municipalities. A motion was moved by Mr. Boucher and was seconded by Mr. Smalley to grant preliminary land development approval. The motion carried.

<u>Lehigh Valley Health Network (LVHN) – Request for Grading</u> – Attorney Siegfried for LVHN asked for approval to grading activity subject to conditions set forth by the Township. Mr. Boucher made a motion to authorize earthmoving activity by applicant, Lehigh Valley Health Network, as depicted on their land development plan submission, submitted January 2, 2019, conditioned upon the following conditions:

- 1. Approval of Township Engineer
- 2. Approval of Northampton County Conservation District
- 3. Execution of preliminary land development improvements agreement drafted by the Township Solicitor containing:
  - a. Full description of work to be performed

- b. Acknowledgement that work is being performed at applicant's own risk
- c. Hold Harmless agreement for any and all activity
- 4. Letter of Credit consistent with estimate prepared by the Township Engineer for all earthmoving activities including soil erosion controls.
- 5. Establish escrow
- 6. Pre-Construction Meeting

The motion was seconded by Ms. Templeton. The motion carried

#### **Supervisors' Comments**

Mr. Smalley had no comments.

Mr. Hoyer stated he attended the LVPC Regional Comp Plan meeting on January 14, 2019. He stated that the entire COG was in attendance and that they are moving in the right path.

Ms. Templeton stated that emergency services are having a difficult time responding to incidences in the Fields of Trio Farms development at night because the homes do not have reflective numbers on the homes. She asked for the township to look into anything that can be done to help with this deficiency. Mr. Hoyer also stated that he has heard that the ambulance corps is having similar trouble throughout Lower Nazareth Township when responding to calls at night, and that we should look into a solution for the entire Township.

Mr. Boucher had no comments.

Mr. Pennington stated that he also attended the LVPC Regional Comp Plan meeting.

#### **Engineer's Report**

Mr. Kortze stated that he has sent the paperwork to the LVPC for the updated Newburg Road Intersection as well as the updated traffic impact plan.

#### Solicitor's Report

There was no discussion under Solicitor's Report

#### Manager's Report

<u>Time Extension Report</u> – Ms. Stauffer stated the Township accepted a time extension for Lot 6 & 7, Hecktown Road Business Park Preliminary Land Development plan until January 27, 2019.

<u>2019 FDR Project – Authorization to Advertise for Bids.</u> Ms. Stauffer asked for authorization to advertise for bids for the 2019 FDR Project that will include Stephanie Drive, Kimberly Court, Sarah Beth Lane, and Troy Court. A motion was made by Mr. Boucher and seconded by Mr. Smalley. The motion carried.

Emergency Operation Plan- Resolution #LNT-08-19- A draft of the updated Emergency Operations Plan prepared by Hugh Harris in his capacity as Emergency Management Coordinator, was provided to the Board for review. Ms. Stauffer explained the changes from the previous plan and indicated the Board would need to adopt a resolution indicating the acceptance of the plan. A motion was moved by Mr. Hoyer to adopt Resolution #LNT-08-19. It was seconded by Ms. Templeton. The motion carried.

<u>CarMax – Revised Improvements Agreement</u>- Ms. Stauffer explained a revised improvements agreement was prepared by Solicitor Asteak as a result of some changes, including a change to the amount required for improvements. A motion was moved by Mr. Boucher to authorize the Chairman to execute the revised improvements agreement for the CarMax project and seconded by Ms. Templeton. The motion carried.

Public Works Snow Plow Purchase – Ms. Stauffer stated during the course of the Township's budget discussions it was noted that the Public Works Department was requesting approximately \$12,000 for a new snow plow to replace the existing plow originally purchased in 2002. The existing plow is rotting and is no longer functional for snow removal purposes. The Board appropriated money for this purchase in the Capital Equipment Fund. A quote was obtained from Structural Metal Fabricators (SMF) under COSTARS contract for \$11,650.00. Ms. Stauffer requested authorization to order the new snowplow to replace the 2002 snowplow. A motion was moved by Mr. Smalley to purchase the new snowplow as quoted by SMF. It was seconded by Mr. Boucher. The motion carried.

There was no discussion under Old Business.

#### **New Business**

There was no discussion under New Business.

#### Payment of the Bills

A motion was moved by Mr. Boucher and was seconded by Mr. Hoyer to approve payment of the bills dated January 23, 2019. The motion carried.

#### **Courtesy of the Floor**

<u>Travis Gerould, 463 Schoolhouse Road,</u> asked if we knew when and where the speed radar devices would be in and placed. Ms. Stauffer stated that the company that was applying for Penn Dot certification had been granted the certification and that the Township had ordered the devices and that they should arrive in February. Mr. Kortze stated that they would be applying for temporary permits and this will allow them to have the flexibility of moving the signs to different trouble spots throughout the township.

<u>Jeff Shepherd</u>, 4485 Whitetail Drive, asked if the Township could please see if there are any examples of acceptable reflective numbers for his subdivision. Ms. Stauffer stated that they would look into what options are available.
