## LOWER NAZARETH TOWNSHIP BOARD OF SUPERVISORS MINUTES FEBRUARY 27, 2013

The Lower Nazareth Township Board of Supervisors held a regularly scheduled meeting in the Township Municipal Building on Wednesday February 27, 2013. The Vice Chairman called the meeting to order at 6:38 PM.

### Approval of Minutes

A motion was moved by Mr. Green and was seconded by Mr. Boucher to approve the meeting minutes for February 13, 2013. Mr. Pennington abstained. The motion carried.

Mr. Pennington acknowledged the receipt of the Financial Report for January 2013.

#### Correspondence

There were no items to discuss under Correspondence.

## Subdivision and Land Development

<u>Saratoga Farms – Waiver Requests</u> – The developer request waivers from (1) Section 774.32.b which deals with side slopes on the detention pond, (2) Section 774.32.c dealing with the type of liner in the pond, and (3) Section 749.1 which requires curbing and sidewalks.

The Board felt strongly about requiring sidewalks on both sides of the street so request #3 was denied.

A motion was moved by Mr. Kucsan and was seconded by Mr. Green to approve waiver request #1 and #2. The motion carried.

<u>Saratoga Farms – Preliminary Subdivision Plan</u> – Mr. Piperato and Mr. Heckman gave a brief presentation of the subdivision plan.

Board of Supervisors Minutes February 27, 2013

There was a lengthy discussion on the extension of Hartman Road. Numerous residents voiced concerns with extending Hartman Road. Tamara Karabinus, 395 Hartman Road, stated that she is already managing a lot of water and fears more flooding with the additional development and opening of the road. Increased traffic also was a concern. Scott Killino, 382 Hartman Road; Earl Snyder, 385 Hartman Road; Kellie Noble, 398 Hartman Road; David Hartranft, 4321 Newburg Road; Albert DeAngelis, 384 Hartman Road; and Dolores Hartman, 394 Hartman Road all voiced similar concerns.

Mr. Pennington thought the Board should defer a decision until Mr. Nagle could be present to give his opinion. Mr. Boucher and Mr. Green were in favor of making the decision tonight to eliminate the extension.

A motion was moved by Mr. Green and was seconded by Mr. Boucher to have the developer eliminate the Hartman Road extension and grant the Township the right of way so that, if needed in the future, the road can be extended. The motion carried.

### Supervisors' Comments

Mr. Boucher asked Mr. Tenges to look into access to Mikron Road during the bridge construction.

Mr. Boucher also stated that the Board wanted to assure residents there would be EMS coverage. Mr. Tenges took over and asked the Board to approve Resolution #LNT-10-13 which makes Bethlehem Township our primary ALS and BLS provider effective midnight February 28, 2013. A motion was moved by Mr. Boucher and seconded by Mr. Green to approve Resolution #LNT-10-13. The motion carried.

Mr. Pennington attended the CRPC meeting Monday evening. He stated that talks continue on police service for Nazareth Borough.

Mr. Green and Mr. Kucsan had no comments.

## Manager's Report

<u>Time Extension Report</u> – Mr. Tenges reported that the Township accepted a time extension for the Charles Chrin Preliminary/Final Minor Subdivision through March 31, 2014.

Newburg Road Truck Restriction Request – PADOT Response – Mr. Tenges refreshed the Board on the request by Mr. and Mrs. Savastano to have the Township write a letter to PADOT requesting a truck restriction on Newburg Road. Mr. Tenges then read PADOT's response which concluded that no truck restriction is necessary for Newburg Road and that the roadway can accommodate any vehicle licensed by the Commonwealth.

<u>Sewage Enforcement Officer – Court Costs Reimbursement</u> – Mr. Tenges briefed the Board on the situation where we took a resident to the Magistrate for failing to repair a faulty septic system. The Sewage Enforcement Officer incurred costs associated with preparing the citation, speaking with the Magistrate, and attending the hearing. Mr. Tenges would the resident to pass those fees and asked the Solicitor if that was permissible.

A motion was moved by Mr. Boucher and was seconded by Mr. Pennington to authorize the Solicitor to investigate our options to recoup the costs from the Sewage Enforcement Officer. The motion carried.

<u>CRPC Articles of Agreement – Amended – Mr. Tenges presented the Board with the final draft for the Amended Articles of Agreement. A motion was moved by Mr. Kucsan and was seconded by Mr. Boucher to authorize the Solicitor to prepare the ordinance to adopt the articles of agreement. The motion carried.</u>

<u>Municipal Building Roof Replacement</u> – Mr. Tenges reported that roof of the Municipal Building needs to be replaced. The Township has received multiple proposals ranging from \$24,000.00 down to \$18,525.00. The

lowest proposal comes from Michael Richline, who comes highly recommended. This amount keeps us under the amount required to get bids.

A motion was moved by Mr. Green and was seconded by Mr. Kucsan to authorize approval of the proposal from Michael Richline. The motion carried.

<u>623 Municipal Drive Tenant</u> – Mr. Tenges reported that one of the tenants at 623 Municipal Drive will be exiting as of Monday.
