Mr. Pennington stated that he attended the Colonial Regional Police Meeting where they discussed the current agreement between the participating townships. Mr. Pennington also stated that at the Nazareth Cog Meeting that Northampton Community College would be offering training for Fire and Emergency Medical personnel to make sure they are up to date on C.E.R.T. (Community Emergency Response Team) training.

Mr. Green commented that he sat in on the Planning Commission Meeting and was very impressed with how the Board conducted the meeting.

Mr. Boucher stated that he would like to have Penn Dot move the sign they placed on Rt. 191 to allow for better visibility. Mr. Tenges responded to Mr. Boucher's requested by telling him that a request had already been made to Penn Dot and asked for the sign to me moved.

#### Manager's Report

<u>Time Extension Report</u> – Mr. Tenges reported that Charles Chrin Preliminary/Final Minor Subdivision has granted the Township an extension until March 31, 2012.

<u>Nazareth COG Meeting</u> – Mr. Tenges stated he also attended the COG meeting and stated the importance of the C.E.R.T. training.

<u>Christian Springs Road Update</u> – Mr. Tenges also spoke about the sewer connection issues on Christian Springs Road. He said that it was decided that we would follow Department of Environmental Protection (DEP) direction and that we will be submitting a task activity report to the D.E.P. In addition, a 537 study will be conducted and should take 3 – 5 months to complete. Any concerns that are found will be addressed at that time. It was also brought to the Managers attention that a survey will need to be mailed to all property owners regarding the public needs dealing with public sewers.

248 Brodhead Road Building Committee - Mr. Tenges stated that he attended a 248 Brodhead Road meeting.

Employee Health Insurance — Tenges ended by stating that Township began participating in a new health insurance program last year that is exclusive for Municipalities and offers refunds to Municipalities that do not abuse claims. Mr. Tenges was pleased to report that Lower Nazareth Township received a refund in the amount of \$25,000.00 for their efforts in keeping health care costs down.
