The Lower Nazareth Township Board of Supervisors held a regularly scheduled meeting at the Lower Nazareth Municipal Building on Wednesday March 14, 2018. The Chairman called the meeting to order at 6:40 PM.

Approval of Minutes

Mr. Pennington requested the minutes be amended to reflect that the Board held an executive session prior to the meeting on February 28th. A motion was moved by Mr. Boucher and was seconded by Ms. Templeton to approve the amended February 28th meeting minutes. The motion carried.

Mr. Pennington acknowledged the receipt of the Hecktown Fire Report for February 2018.

Correspondence

Ms. Stauffer indicated that the Township is in receipt of three letters of support from Senator Scavello, Bushkill Township, and Hanover Township for Lower Nazareth's grant application to Northampton County to cover 50% of the cost to update our Parks and Recreation Plan.

Subdivision and Land Development

<u>Presentation by Jaindl Development</u> — Mr. Pennington stated that Mr. Jaindl was scheduled to make a presentation at tonight's meeting for his proposal on the development of the speedway property. Mr. Pennington indicated that Mr. Jaindl has met with Township Staff and a few Board members and was informed that there are major traffic issues that need to be addressed. The Township is planning a workshop meeting in May at Lower Nazareth Elementary School to hear the presentation and accept public comments. Once scheduled, the meeting will be advertised in the newspaper as well as on the Township's website.

Supervisors' Comments

There were no comments under Supervisor's Comments.

Manager's Report

Resolution #LNT-17-18 — Authorization to apply for funding to update Parks and Recreation Plan — Ms. Stauffer commented the current plan was adopted in 1989. The quote received to update the plan is \$55,000. This grant application to Northampton County would cover 50% of that cost. A motion was moved by Mr. Bickert and was seconded by Ms. Templeton to approve Resolution #LNT-17-18. The motion carried.

Resolution #LNT-18-18 — Authorization to apply for DCNR funding — Ms. Stauffer stated that we are looking for funding to install a walking path and playground at our 90 acres for a proposed cost of \$350,000. This grant application to DCNR would cover 50% of that cost and Ms. Stauffer is hoping to apply for another grant for the remaining 50%. Ms. Stauffer noted that these grants are extremely competitive and not guaranteed. She also commented that to apply for this, and other grants, we need to update our Parks and Recreation Plan. A motion was moved by Mr. Kucsan and was seconded by Ms. Templeton to approve Resolution #LNT-18-18. The motion carried.

Soccer Fields – Ms. Stauffer reported that they have a meeting with the Northampton County Conservation District on March 21st for our NPDES permit required for this project.

<u>DEP Grant Application</u> — We are applying for a recycling grant 902 to purchase the following items for our yard waste facility; a security fence, security cameras, a 10-yd leaf vac, a grappling bucket, a utility tractor with loader, as well as pave the roadway into the facility. The cost of this project is \$300,000. This grant would cover 90% of the project costs. Ms. Stauffer commented that DEP noted that is we would go to a single hauler we would be eligible for even more funding. She also thanked Mr. Albert for all his assistance with these grants.

<u>Draft Personnel Policy</u> – Ms. Stauffer asked the Board for comments on the draft personnel policy she distributed to them and will be looking to adopt the policy in the near future.

Payment of the Bills

A motion was moved by Mr. Kucsan and was seconded by Ms. Templeton to approve payment of the bills dated March 14th. The motion carried.

Courtesy of the Floor

Travis Gerould, 463 School House Road, inquired about traffic studies for the projects proposed by Liberty Properties and Jaindl Development. Ms. Stauffer commented that traffic is a major factor that will be reviewed.

Mr. Gerould also commented on the traffic signal being out at Country Club and Hecktown Roads the previous weekend following the storm. He thought we installed battery backups and was curious why it was not working. Ms. Stauffer reported that the batteries are only able to last for so many hours; with the extended power outage they didn't last, and we ended up using generators. Mr. Hoyer, 365 Country Club Road, commented that the light was working all day on Saturday until later in the day.

Jake Towne, 4640 Fir Drive, introduced himself as one the township's elected auditors. He told the Board that he would like to examine files, not audit them. Mr. Towne stated that he has been speaking with the Township

Manager and was told that he would have to file a right-to-know request when he wants records. He informed the Board he would be filing those requests to review the files.
