#### **Approval of Minutes**

A motion was moved by Mr. Green and was seconded by Mr. Boucher to approve the IDI Conditional Use meeting minutes for March 4, 2014. The motion carried.

Mr. Pennington acknowledged the receipt of the Financial Report for February 2014.

**Correspondence** – There were no items to discuss under Correspondence.

#### Subdivision and Land Development

<u>Fields at Trio Farms – Phase IV – Resolution #LNT-08-14</u> – The applicant gave a brief presentation. Mr. Doyle explained that they are proceeding with Phase IV prior to getting approval for Phase III because the latter consists of all townhomes and singles are currently selling faster than townhomes. They will proceed with Phase III when townhomes start selling or they will have to go back to the Planning Commission for changes. Mr. Doyle noted that they are still within the limits of the original plan approval. Mr. Kortze reviewed his March 21<sup>st</sup> letter recommending approval. A motion was moved by Mr. Green and was seconded by Mr. Kucsan to approve resolution #LNT-08-14. The motion carried.

#### **Supervisors' Comments**

Mr. Boucher, Mr. Green, and Mr. Kucsan had no comments.

Mr. Pennington attended the COG meeting last evening. Mr. Pennington was unable to attend the CRPC meeting, however he reported that Mr. Nagle informed CRPC that LNT would have a consultant review Mr. Tenges' police budget numbers. A motion was moved by Mr. Pennington and was seconded by Mr. Kucsan authorizing Mr. Tenges to expeditiously find a consultant to review those numbers. The motion carried.

#### Manager's Report

<u>LNRA – Baseball</u> – Mr. Tenges reported that Township has reviewed the policy, a meeting was scheduled however due to emergencies, individuals from LNRA were unable to attend. The meeting will be rescheduled and Mr. Tenges felt that they would be able to adequately address LNRA's concerns.

<u>2014 FDR Project</u> – Mr. Tenges requested the Board to authorize advertisement for bids for the 2014 FDR project. Roads included in this project are Oakwood, Dogwood, Elm, and Birch. A motion was moved by Mr. Boucher and was seconded by Mr. Green to authorize advertisement for bids for the 2014 FDR project. The motion carried.

<u>COG Attendence</u> – Mr. Tenges attended the COG meeting last evening.

Engineer's Report - There were no items to discuss under Engineer's Report.

#### Solicitor's Report

<u>Curative Amendment – Stone Post Meadows</u> – A letter has been received from Mr. Preston providing a list of available dates to hold the hearing. The supervisors were asked to review their calendars and let Mr. Tenges know if any dates are not suitable so that a hearing date can be determined.

Bethlehem Township Ambulance Agreements – There was a discussion some of the language in the agreement. Mr. Boucher and Mr. Green did not like "subscription mailing" and would rather it say "fund drive mailing." After further discussion Mr. Green and Mr. Boucher agreed to accept the language as is.

Old Business - There were no items to discuss under Old Business.

New Business – There were no items to discuss under New Business.

#### Payment of the Bills
