Solicitor Asteak re-opened the hearing with a brief synopsis of the last meeting and reminded everyone of the ground rules: (1) Redundant comments and questions will not be permitted. (2) Only those with a direct interest will be allowed to comment. (3) Be considerate, quiet (no commenting aloud & silence cell phones), and be respectful.

Blake Marles called rebuttal witness Gavin Biebuyck, Environmental Consultant and Principal of Liberty Environmental to the stand. Mr. Biebuyck expert qualifications were reviewed. Exhibit A-42 was entered into the record.

Mr. Elliot and Mr. Noel questioned Mr. Biebuyuk on his qualifications. Mr. Sheer had no questions.

Based upon the submitted professional profile and subsequent testimony, Mr. Asteak approved Mr. Biebuyck as an expert witness.

Blake Marles continued with rebuttal testimony from Mr. Biebuyuk. Exhibits A-43 through A-49 were entered into the record with no further questions.

Public question and answer of Mr. Biebuyck followed.

Upon completion of public comment, Mr. Asteak called upon Mr. Noel to address surrebuttal. Mr. Noel decided upon calling Mr. Mineo as a fact witness to speak on the Bethlehem Intermodal Terminal built between 2010 and 2012. Exhibit O-42 was entered into the record.

Mr. Asteak advised council they may submit Findings of Fact by August 1, 2014. The next hearing will continue on August 11, 2014 at 6:30 PM at the Lower Nazareth Township Municipal Building.

Mr. Asteak called upon Lori B. Seese, Planning and Zoning Administrator, Lower Nazareth Township to present the petitions received by the township office so they could be entered into the record; Exhibit Z-4.
