LOWER NAZARETH TOWNSHIP BOARD OF SUPERVISORS MINUTES JULY 11, 2012

The Lower Nazareth Township Board of Supervisors held a regularly scheduled meeting in the Township Municipal Building on Wednesday July 11, 2012. The Chairman called the meeting to order at 6:35 PM.

Approval of Minutes

A motion was moved by Mr. Kucsan and was seconded by Mr. Pennington to approve the meeting minutes for June 13, 2012. Mr. Nagle abstained. The motion carried.

A motion was moved by Mr. Green and was seconded by Mr. Pennington to approve the meeting minutes for June 27, 2012. Mr. Kucsan and Mr. Boucher abstained. The motion carried.

Old Business

First Industrial Pennsylvania, L.P. - First Park 33 - Conditional Use Application -

Solicitor Asteak reviewed the hearing held at our June 27th meeting. Mr. Kucsan and Mr. Boucher were absent and could only participate if they read the transcript in its entirety and reviewed the exhibits. Mr. Boucher did not have time to review these documents. Mr. Kucsan certified that he did review the transcript and exhibits. Mr. Davis was present and ok with Mr. Kucsan participating in tonight's discussion.

Solicitor Asteak stated that the Board's options were to deny, approve without conditions or approve with conditions.

Mr. Nagle reviewed the suggested conditions to be placed on the applicant. The suggestions included lowering the building floor elevation, raising the berm, fence height requirements, and landscape requirements.

Mr. Green stated that they are limited to what they can do, the zoning allows for this type of use, but he liked the suggestions.

Mr. Pennington also agreed with the suggestions. He stated that, to the developer's credit, they are trying to minimize the effects of this project.

Mr. Tenges stated that the Board could also require revised site line drawings at the land development stage.

Solicitor Asteak stated that an additional condition could require that all conditions be depicted on the land development plan and that revised sight line drawings, along with a lighting plan, be presented along with their land development submission.

A motion was moved by Mr. Pennington and was seconded by Mr. Kucsan to grant conditional use with the conditions discussed. The motion carried. Solicitor Asteak stated that a written order and opinion with follow.

Reports

All reports are available to review at the Township Office and on our website.

Mr. Nagle acknowledged the receipt of the Hecktown Volunteer Fire Company Incident Report for June 2012 and the Zoning Administrator's Report for June 2012.

Correspondence

There were no items to discuss under Correspondence.

Subdivision and Land Development

There were no items to discuss under Subdivision and Land Development.

Supervisors' Comments

Mr. Boucher, Mr. Green, and Mr. Kucsan had no comments.

Mr. Nagle reported that the CRPC meeting was rescheduled to July 16th.

Mr. Pennington inquired about the numerous power outages over the weekend. The traffic light at Newburg Road and Route 191 was out for quite some time.

Mr. Tenges stated they are prepared with portable stop signs. We are currently exploring options to get grants to install battery back-ups in the traffic signals. He noted that we do have a generator and are able to connect it to newer intersections; however Newburg Road is an older intersection.

Manager's Report

<u>Time Extension Report</u> – Mr. Tenges reported that the township accepted a time extension for the Brown Daub Fiat Conditional Use. The new project review period ends October 27, 2012.

Road Project LNT-02-12 – A motion was made my Mr. Boucher and was seconded by Mr. Green to award the bid to the lowest bidder, Recon Construction at \$185,797.00. The motion carried. Mr. Tenges commented that this project would be paid out of State Liquid Fuels.

Road Project LNT-03-12 – A motion was made my Mr. Kucsan and was seconded by Mr. Pennington to award the bid to the lowest bidder, Midland Asphalt at \$52,701.25. The motion carried.

<u>Werner Road Response – Upper Nazareth Township</u> – Mr. Tenges stated we sent a letter to Upper Nazareth Township asking them to participate in a traffic study of Werner Road. He reported that they responded and are not interested at this time.

Road Line Striping – Mr. Tenges reported that the line striping throughout the township is complete.

623 Selvaggio Drive Trash Removal – Mr. Tenges reported that township crews removed a 40 cubic yard container of trash from 623 Selvaggio Drive. An invoice, in the amount of \$645, was sent to them.

BOS Meeting Cancellation – A motion was moved by Mr. Nagle and was seconded by Mr. Kucsan to cancel the July 25th meeting. The motion carried. The next meeting will be August 8th.

Renaming Selvaggio Drive – Mr. Tenges requested suggestions for renaming Selvaggio Drive. Mr. Nagle suggested Municipal Drive. Mr. Tenges asked for authorization to start the process of renaming the road and to establish a date to give time to notify the businesses of the change. Mr. Nagle made a motion, which was seconded by Mr. Green, to change Selvaggio Drive to Municipal Drive effective October 1, 2012. The motion carried.

Engineer's Report

Regency Centers (Lower Nazareth Commons) – Letter of Credit Release:

<u>Corriere Road & Northwood Avenue</u> – Mr. Kortze reviewed his letter recommending the release of the remaining \$200,042.12 in security. A motion was moved by Mr. Boucher and was seconded by Mr. Pennington to authorize the release of the remaining security. The motion carried.

<u>Dryland Way & Wegmans Drive (Lots 1 & 5)</u> – Mr. Kortze reviewed his letter recommending the release of the remaining \$227,950.10. A motion was moved by Mr. Kucsan and was seconded by Mr. Pennington to authorize the release of the remaining security. The motion carried.

Solicitor's Report

<u>Griffin Intermunicipal Agreement Ordinance #206-07-12</u> – A motion was moved by Mr. Green and was seconded by Mr. Kucsan to adopt Ordinance #206-07-12.

Neighborhood Improvement Zone (NIZ) – Solicitor Asteak reported that the issue has been corrected and Earned Income Taxes (EIT) can no longer be held by Allentown. The first two quarters will be refunded. He asked for authorization to withdraw from the lawsuit. A motion was moved by Mr. Boucher and was seconded by Mr. Pennington to withdraw from the lawsuit. The motion carried.

New Business

There were no items to discuss under New Business.

Payment of the Bills

A motion was moved by Mr. Green and was seconded by Mr. Pennington to approve payment of the bills dated July 11, 2012. The motion carried.

Courtesy of the Floor

Charles Young, 432 Heritage Lane, complained about chronic power failures and requested the Board of Supervisors send a letter to PPL to investigate.

Mr. Nagle recused himself from the conversation because he is employed by PPL.

Mr. Kucsan agrees that it seems like a particular stretch is affected by repeated outages.

Mr. Tenges did not think we had any more power with PPL than a power paying customer. He also said we would need to confirm the frequency of outages and residents affected.

Mr. Green thought we should send a general letter to PPL.

Mr. Boucher agreed that the underground lines in that area are poor. The lines in the area of Manor Drive were recently replaced.

Mr. Tenges added that the lines are currently being replaced at Ash and Georgetown Roads.

A motion was moved by Mr. Green and was seconded by Mr. Boucher authorizing Mr. Tenges to look into the failures and send a letter to PPL. Mr. Nagle abstained. The motion carried.

<u>Adjournment</u>

A motion was moved by Mr. Boucher and was seconded by Mr. Pennington to adjourn the meeting. The meeting adjourned at 7:26pm.
