### LOWER NAZARETH TOWNSHIP BOARD OF SUPERVISORS MINUTES July 22, 2020

The Lower Nazareth Township Board of Supervisors held a virtual meeting on Wednesday July 22, 2020. The Chairman called the meeting to order at 6:30PM.

#### **Approval of Minutes**

A motion was moved by Mr. Boucher and was seconded by Mr. Brown to approve the July 8<sup>th</sup> meeting minutes. The motion carried unanimously.

#### **Speakers**

Judy Goldstein – Gilmore Associates – Recreation, Parks and Open Space Plan and Official Map Update – Ms. Goldstein stated that she has taken over the duties of drafting the Township's new Recreation Plan and is hoping to have a first draft for the Board to review before the end of August. Mr. Hoyer stated that he noted two corrections that need to be made to the map and that he will make sure to share the corrections with Ms. Goldstein. Mr. Hoyer also wanted it noted that the EAC has made very good comments concerning the Recreation Plan and Map update and that they moved this along very quickly. Ms. Stauffer did ask that the once the Board has reviewed everything if they could please relay any questions or concerns to her so that she has time to make Ms. Goldstein aware of them. Ms. Goldstein will start sending updates to Ms. Stauffer as changes are made.

Bill Dingman – Gilmore Associates – Georgetown Manor Sewer – Mr. Dingman reviewed what the steps would be needed for the Township to begin a study for the need for sewer within Lower Nazareth Township. Mr. Dingman stated that the first step would be to have a meeting with DEP and share with them the scope of the project. Once DEP has approved of the project they will help with the planning. Mr. Dingman stated that it would take a minimum of one year to complete this study. Mr. Dingman said the Board would also need to decide if they were looking to examine the entire Township or specific areas within the Township. Mr. Pennington stated he felt the Board might be remiss if we didn't have the study done to be Township wide and that a comprehensive plan for the Township would give them better information to share with the public once its complete. Mr. Hoyer asked if the plan was to encompass the entire Township and that the work was to be done in phases, would the Township be locked in to doing all of the phases and can the phases be re worked if they feel the needs of the area has changed. Mr. Dingman stated that if the Township would decide to do this in phases, that the phases can be

changed at any time to reflect the current needs of the residents. A motion was moved by Ms. Templeton and seconded by Mr. Brown for the Township Manager to work with the Gilmore and Associates to contact DEP to begin discussions. The motion carried unanimously.

Katina Boyce – Verizon Wireless – Small Antenna Proposal – Ms. Boyce stated that Verizon Wireless is looking to add 4 small antennas though out the 248 corridors to expand their 5G coverage for smart devices. Ms. Boyce stated that the antennas would be affixed to existing traffic poles where possible or they will be placed on new wooden poles. Mr. Boucher asked how they would power these antennas. Ms. Boyce stated that they would run fiber to each antenna and run a line to the closest power supply and fit it with its own electric meter for each antenna. Mr. Hoyer wanted to know what the time frame for this project would be. Ms. Boyce state they would start as soon as possible to meet the demands of their cellular customers. Ms. Templeton asked if they know of any health concerns that these small antennas may have. Ms. Boyce stated that these antennas are placed high off the ground as a precaution, but at this time there are no known health risks associated with the use of these antennas.

#### Supervisors' Comments

Mr. Brown had no comments.

Mr. Boucher had no comments.

Mr. Hoyer had no comments.

Mr. Pennington stated that the NAZCOG Multi-Municipal Plan Update is hoping to be done early next year. He also attended the CRPD meeting and that he and Mr. Boucher stressed that it was imperative to be modest with any increase in CRPD's budget for next year.

Mr. Boucher also stated that he attended the CRPD meeting with Mr. Pennington.

#### Subdivision & Land Development

<u>Faust Sketch Plan</u> – Mr. Faust stated that they have reworked the parking spaces and now have plans to offer parking on the ground floor under the building if the zoning allows for that. He stated that the zoning allows for a maximum of three floors of habitable living space with no height restrictions for apartments but wanted to make sure that this was allowed since the technical ground level would be designated for parking. Ms. Seese stated that the Zoning Ordinance limits building height to 35 feet, except for apartments. In addition, apartments may not include more than 3 habitable stories. In her opinion that habitable living space is for dwellings and not for vehicle parking; therefore, the parking is permitted under the buildings.

<u>Jaindl Route 248 Warehouse Subdivision and Land Development</u> – A motion was made by Ms. Templeton and seconded by Mr. Brown to allow Jaindl Route 248 Warehouse Subdivision and Land Development to enter into an Indemnification Agreement with the Township. The motion carried unanimously.

<u>LVHN Phase 2 – Preliminary/Final Land Development – Resolution #LNT-20-20</u> – Mr. Kortze reviewed his July 21<sup>st</sup> letter recommending plan approval. In response to concerns about the location of the helipad, Brent Tucker, of The Pidcock Company, commented that this site is planned to be a small community hospital, not a trauma center. Therefore, a helicopter will not be staged onsite and will only be used to transport patients to other hospitals. A motion was moved by Mr. Brown and was seconded by Ms. Templeton to approve Resolution #LNT-20-20. The motion carried unanimously.

#### Solicitor's Report

There we no comments under Solicitor's Report.

#### **Engineer's Report**

Walking Trail – Barwis Construction Final Payments – Mr. Kortze reviewed his July 20<sup>th</sup> letter and recommended final payment for this project for a total of \$36,286.89. A motion was moved by Mr. Boucher and was seconded by Mr. Hoyer to approve final payment for the walking trail. The motion carried unanimously.

## Manager's Report

Ms. Stauffer stated that the Township had accepted a time extension for Colts Run South II Conditional Use until October 8<sup>th</sup> of 2020. The Township has also accepted a time extension for Colts Run South II Land Development until November 7<sup>th</sup> of 2020.

#### Payment of the Bills

A motion was moved by Mr. Boucher and was seconded by Mr. Brown to approve payment of the bills dated July 22<sup>nd</sup>. The motion carried unanimously.

#### **Courtesy of the Floor**

There were no comments under Courtesy of the Floor.
