LOWER NAZARETH TOWNSHIP BOARD OF SUPERVISORS MINUTES OCTOBER 9, 2013

The Lower Nazareth Township Board of Supervisors held a regularly scheduled meeting in the Township Municipal Building on Wednesday October 9, 2013. The Chairman called the meeting to order at 6:30 PM.

Approval of Minutes

Approval of the meeting minutes was tabled due to the lack of quorum from the previous meeting.

Reports

Mr. Nagle acknowledged the receipt of the Financial Report for August 2013, the Hecktown Volunteer Fire Company Incident Report for September 2013, and the Planning and Zoning Administrator's Reports for August and September 2013.

Georgetown Road Bridge Replacement Presentation – Mr. McGloughlin, Borton-Lawson Engineering, reported that the existing bridge over the Monocacy Creek at Georgetown Road is a single span concrete encased steel beam structure. The bridge load is 20 tons and is considered structurally deficient and functionally obsolete.

Work is scheduled to begin in the spring of 2015 and end that fall. The bridge will be closed during construction and the proposed detour required will utilize Hanoverville Road, Township Line Road, Steuben Road, and Georgetown Road.

The proposed bridge will be 10' wider than the existing structure with 11' lanes and 3' shoulders. It will have a reinforced concrete deck and parapets. There will be no weight restrictions. In addition to the bridgework, there will also be roadway and railway crossing improvements

Michelle Rehbogan, ASC Group, reported on the environmental investigations that indicated that there are no impacts to wetlands, archeology resources, or endangered species. The bridge is not considered historic nor does it contribute to a historic district.

Mr. Green inquired about access and was told there would be no restricted access, residents will have access to their property and driveways will remain open.

Mr. Tenges inquired about improvements to Township Line Road and noted that, in its current condition, is not the best detour route. Mr. McGloughlin commented that trucks already cannot use the bridge so they will just continue to use whatever route they are currently using, but that they could look into improvements as well.

Correspondence

There were no items to discuss under Correspondence.

Subdivision and Land Development

There were no items to discuss under Subdivision and Land Development.

Supervisors' Comments

Mr. Green and Mr. Kucsan had no comments.

Mr. Boucher commented on the poor paving on the PADOT bridge project on Route 191. Mr. Tenges agreed and stated that we would be reaching out to them to complain about the poor ride quality.

Mr. Nagle was unable to attend the CRPC meeting but commented on the draft budgets CRPD is proposing. One budget would include no additional officer and a \$36,595 increase for Lower Nazareth. The other, an additional officer and a \$61,489 increase. Mr. Tenges is hoping to have a 2014 Draft Lower Nazareth General Fund Budget available for the Board at our next meeting. In his early review of next year's proposed tax revenue, Mr. Tenges only sees an increase of about \$33,000. He commented that the police budget continually consumes more and more of our additional tax revenue. Mr. Tenges also commented that while the police budget has increased year after year, Lower Nazareth has actually reduced our budget 2 years in a row.

Manager's Report

Memorial Library of Nazareth Library Board – Mr. Tenges reported that our current representative on the Library Board will not be returning. In addition, the Library will be restructuring their Board by amending their by-laws. Mr. Tenges requested that if the Board members knew anyone who may be interested.

Engineer's Report

There were no items to discuss under Engineer's Report.

Solicitor's Report

Solicitor Asteak stated that he has prepared an Abandoned Property Ordinance and it is currently under review by Mr. Tenges. He also reported that the Hecktown Volunteer Ambulance Corps agreements are under review.

Old Business

There were no items to discuss under Old Business.

New Business

There were no items to discuss under New Business.

Payment of the Bills

A motion was moved by Mr. Kucsan and was seconded by Mr. Boucher to approve payment of the bills dated October 9, 2013. The motion carried.
