#### LOWER NAZARETH TOWNSHIP BOARD OF SUPERVISORS MINUTES February 24, 2010

The Lower Nazareth Township Board of Supervisors held a regularly scheduled meeting in the Township Municipal Building on Wednesday February 24, 2010. The Chairman called the meeting to order at 6:30 PM.

#### Approval of Minutes

A motion was moved by Mr. Kucsan and was seconded by Mr. Johnson to approve the meeting minutes for January 27, 2010. The motion carried.

#### Reports

Reports are available for review at the Township Office and are posted on the Township's website.

Mr. Nagle acknowledged the receipt of the Hecktown Volunteer Fire Company's Incident Reports for January 2010, the Hecktown Volunteer Ambulance Corps Incident Report for January 2010, and the Financial Report for January 2010.

#### Correspondence

There were no items to discuss under Correspondence.

#### Subdivision and Land Development

There were no items to discuss under Subdivision and Land Development.

#### **Supervisors' Comments**

Mr. Boucher congratulated the road crew on the condition of the roads after the latest snow storm. Compared to other townships, Lower Nazareth Township roads were top-notch.

Mr. Johnson had no comments.

Mr. Nagle echoed Mr. Boucher's comments to the Public Works Department. In addition, he attended the Colonial Regional Police Commission (CRPC) meeting on Monday night. Officer Schippang completed his probation period and was accepted as a full-time officer. The police department is continuing their search for a new administrative assistant.

Mr. Pennington attempted to attend the COG meeting; however it was cancelled due to inclement weather.

Mr. Kucsan attended the CRPC meeting.

#### Manager's Report

<u>2010 Road Projects</u> – Mr. Tenges requested authorization to put a micro-surfacing project out for bid. The roads to be included are the roads that were completed in the fall and a few additional roads. A motion was moved by Mr. Kucsan and was seconded by Mr. Pennington to put this project out for bid. The motion carried.

Mr. Tenges also discussed the second phase of the road rehabilitation project. He requested authorization to borrow money to complete the project. Based on the current costs, we would need to borrow about \$3.2 million. The debt would be repaid with State Liquid Fuels (SLF) and other township funds. Mr. Tenges also stated that the remaining timeline for the project could possibly be reduced to two years.

While the township is borrowing money, Mr. Tenges asked the Board if they were inclined to look into a new building. The township already owns 90 acres at Gremar and Daniels Roads. This building is old and we have outgrown the space. The township has spent money on new buildings for our fire company and police department. Mr. Tenges noted that there would be no tax increase to fund this new building.

Keystone Consulting Engineers already designed a master site plan. Lower Nazareth Township Public Works has even begun a road network on the property. Mr. Tenges asked for authorization to pursue a building design.

Mr. Nagle stated that the land has been just sitting since it was purchased in 2001/2002 and it is obvious that we have outgrown the space; therefore perhaps now is the time to build a new building.

Mr. Pennington inquired what would become of the current facility. Mr. Tenges suggested it be utilized by parks and recreations and the seniors.

Mr. Kucsan commented that it's time for a new building. He would like to see this done, but doesn't believe we need anything elaborate.

Mr. Boucher and Mr. Johnson both believed it was worth pursuing.

A motion was moved by Mr. Nagle and was seconded by Mr. Boucher to authorize Mr. Tenges to get a building design for a new municipal building. The motion carried.

<u>Field One – Rehabilitation Proposal</u> – Lower Nazareth Recreation Association (LNRA) submitted a proposal in the amount of \$4,380.00 for the work on field one. They will cover the expenses and are merely asking for our approval to complete the work. The work will be coordinated with us and we will need a Certificate of Insurance prior to commencement of the work. A motion was moved by Mr. Johnson and was seconded by Mr. Boucher to approve this project. The motion carried.

<u>Planning Commission Vacancy</u> – Mr. Tenges reported that Bill Hughes has resigned from the Planning Commission. He thanked Mr. Hughes for his contribution. Mr. Tenges asked that if the Board knows of anyone interested in being on the Planning Commission to submit a letter of interest.

<u>248 Brodhead Road Building Committee</u> – Mr. Tenges commented that he attended the reorganization meeting on the 248 Brodhead Road Building Committee and also toured the facility along with other members of the committee.

<u>COG Steering Committee</u> – Mr. Tenges attended the COG Steering Committee meeting. At the meeting, Olev Taramae presented possible uses for the racetrack site.

<u>Trinity Property</u> – Mr. Tenges reported that he has been working with Solicitor Asteak and Trinity Church in an effort to purchase the "triangle" at Hecktown and Butztown Roads. The purpose would be to realign Butztown Road and Route 191 and to maximize space for an overflow parking lot. A motion was moved by Mr. Pennington and was seconded by Mr. Boucher to get the land appraised in order to make an offer. The motion carried.

<u>Ashley Development (Trio Farms)</u> – As an "FYI", Mr. Tenges reported that Ashley Development is seeking relief from their age-qualified approval. Ashley Development was before the Zoning Hearing Board this month and the hearing continues in March.

Route 33 Interchange in Tatamy – Mr. Tenges read a quote from an article in Saturday's newspaper regarding the proposed interchange. County Councilman, John Cusick, was quoted as saying "My hope is that what goes in there is not like what we have seen go in along (Route 248)." Mr. Tenges commented that the benefits of development along Route 248 are huge. The total tax revenue to the school district for that corridor is \$3.5 million and the county receives \$850,000. Mr. Tenges believes that Mr. Cusick should have done his homework before making that comment because development along an interchange has many benefits.

Snow Removal Complaint – Mr. Tenges shared an email with the Board regarding a resident's displeasure with snow being "dumped" at the base of his driveway. He also shared his response to the resident which Mr. Nagle thought was both politically correct and politic.

<u>Sewer Allocation Request - Lowe's - Lowe's Home Centers.</u> Inc. submitted a request for sanitary sewer allocation. They would like to purchase 2,508gpd from Easton Hospital. Lowe's also submitted a letter from Easton Hospital granting this allocation. A motion was moved by Mr. Pennington and was seconded by Mr. Boucher to approve the sewer allocation request. The motion carried.

Lower Nazareth Realty Partners – Improvements Agreement – Authorization to Execute – Two improvements agreements will be required for the development on WaWa. Lower Nazareth Realty Partners will be party to one and WaWa the other. A motion was moved by Mr. Johnson and was seconded by Mr. Kucsan to authorize both agreements for execution, upon the satisfaction of the Township Manager and Solicitor. The motion carried.

Mr. Tenges commented that there would be a brief executive session after the meeting to discuss a personnel matter.

#### **Engineer's Report**

Mr. Kortze stated he will supply Board members with copies of the Master Plan.

#### Solicitor's Report

Solicitor Asteak reported he will run the advertisement for the Stop Sign Ordinance that will be considered for adoption at our March 10, 2010 meeting.

#### **Old Business**

There were no items to discuss under Old Business.

#### **New Business**

<u>Bridge Replacement Project – Route 191 over Monocacy Creek</u> – Donald Lerch of McTish, Kunkle & Associates; Michael McGuire of McCormick Taylor; and Jerilyn Luben of L&V Engineering were present for the presentation.

Mr. Lerch discussed the estimated time schedule which starts with receiving bids in summer of 2010 and concluding in the summer of 2012.

Message boards will be posted on Route 248, Route 22, and Route 191 informing motorists of this construction. There will be at least one lane of traffic open at all times, except for certain phases when

Board of Supervisors Minutes February 24, 2010 traffic will be stopped for 20 minutes at a time. This will only occur during the hours of 9:00PM Saturday and 9:00AM Sunday.

Ms. Luben discussed the restricted access to nearby business and temporary right-of-way (ROW) access required.

Mr. McGuire commented that the bridge's foundation is solid; it is just a timely repair.

#### Payment of the Bills

A motion was made by Mr. Johnson and seconded by Mr. Pennington to approve the bills dated February 24, 2010. The motion carried.
