# LOWER NAZARETH TOWNSHIP BOARD OF SUPERVISORS MINUTES March 24, 2010

The Lower Nazareth Township Board of Supervisors held a regularly scheduled meeting in the Township Municipal Building on Wednesday March 24, 2010. The Chairman called the meeting to order at 6:45 PM.

#### **Approval of Minutes**

A motion was moved by Mr. Pennington and was seconded by Mr. Johnson to approve the meeting minutes for March 10, 2010. The motion carried.

### Reports

There were no items to discuss under Reports.

#### **Correspondence**

There were no items to discuss under Correspondence.

#### Subdivision and Land Development

<u>Lowe's Home Centers, Inc. – Waiver Requests</u> – Mr. Kortze reviewed his letter dated March 19<sup>th</sup> recommending granting the requested waivers. The applicant sought relief from the following sections: 421, 424.4, 424.7, 774.32b, and 794.48. A motion was moved by Mr. Johnson and was seconded by Mr. Boucher to approve the aforementioned waivers. The motion carried.

<u>Lowe's Home Centers, Inc. – Preliminary/Final Land Development – Resolution #LNT-09-10</u> – Attorney Gavin stated that the Conditional Use appeal has been withdrawn; however the appeal to the Zoning Hearing Board is still pending.

Attorney Gavin stated that the appeal of the zoning hearing board's decision is merely on the way the decision is written. The two issues are on outside storage and display and parking.

Solicitor Asteak stated he couldn't quarrel over the applicant wanting clarification, but was inclined to defer final action until the zoning hearing board appeal and any other issues are resolved.

Mr. Tenges commented that the developer suggested an alternative to the post development traffic analysis. Mr. Tenges said that the developer's idea to post funds to mitigate any deficiencies may be workable. Mr. Tenges and Mr. Kortze will meet with Lowe's representatives to discuss the concept which will be memorialized at final land development approval.

Board of Supervisors Minutes March 24, 2010

There is still an issue with Target regarding the cross access easement. Mr. Tenges firmly believes that it is necessary and that the Board could exercise emanate domain, if Target doesn't comply.

A motion was moved by Mr. Boucher and was seconded by Mr. Pennington to authorize the solicitor to explore condemnation of the easement, if needed, at the expense of the developer.

The Board deferred their decision until their April 14<sup>th</sup> meeting.

<u>Ashley Development – Trio Farms – Letter of Credit Reduction</u> – Richard Brooks of Ashley Development was present. Mr. Kortze reviewed his March 24<sup>th</sup> letter recommending the reduction in the letter of credit to \$318,599.28. This amount is for the completion of Gremar Road and for site security.

This letter of credit from Wachovia (Wells Fargo) will be replaced with a new letter of credit from Bancorp Corp Bank. Mr. Tenges noted that the current LOC will not be released until we have the new LOC in hand.

Mr. Tenges' only concern is the safety of the road and on the property. Solicitor Asteak stated that no building permits would be issued for the site and asked Mr. Brooks his timeframe for completing these improvements. Mr. Brooks believes they will be complete within the year.

Solicitor Asteak stated that an amendment to the subdivision improvements agreement would also be required.

A motion was moved by Mr. Johnson and was seconded by Mr. Pennington to reduce the letter of credit and execute an amendment to the improvements agreement. The motion carried.

# Supervisors' Comments

Mr. Pennington attended a training session for new supervisors. He also attended the COG meeting where Deb Hunter, the Gaming Commissioner was present.

Mr. Nagle, along with Mr. Kucsan attended the Colonial Regional Police Commission meeting.

Mr. Johnson had no comments.

Mr. Boucher attended the second training session for new supervisors. He also attended the re-scheduled Hecktown Volunteer Ambulance Corps meeting.

Mr. Boucher inquired about limiting the areas people can smoke on township property; especially near the baseball fields. Mr. Tenges stated the Board could adopt a smoking policy that would ban smoking except in designated areas. After some further discussion, the Board decided they would think about the permitted smoking areas and discuss it at the next meeting.

#### Manager's Report

<u>2009 Annual Report Memorial Library of Nazareth & Vicinity / Information</u> – Mr. Tenges acknowledged the receipt of this information.

Tax Collection Committee (TCC) – Mr. Tenges attended the TCC meeting and was appointed to dévelop an RFP for TC Services. Mr. Tenges and other individuals involved in this process will have their first meeting tomorrow.

Zoning Hearing Board meeting (Trio Farms project) – Mr. Tenges attended last night's zoning hearing board meeting. An opinion will be rendered on Friday at 5:30pm.

# Solicitor's Report

<u>DeBonis Litigation</u> – Mr. and Mrs. DeBonis have filed a separate action seeking removal of the underground storm sewer pipe. Solicitor Asteak has already spoken with Mr. Tenges and Mr. Kortze regarding this matter and will put in an appearance at the hearing.
