LOWER NAZARETH TOWNSHIP BOARD OF SUPERVISORS MINUTES April 8, 2009

The Lower Nazareth Township Board of Supervisors held a regularly scheduled meeting in the Township Municipal Building on Wednesday April 8, 2009. The Chairman called the meeting to order at 7:35 PM.

Approval of Minutes

A motion was moved by Mr. Nagle and seconded by Mr. Johnson to approve the meeting minutes for March 11, 2009. The motion carried.

Reports

Reports are available for review at the Township Office.

Dr. Dilsaver acknowledged the receipt of the Zoning Administrator's March 2009, the Financial Report for February 2009, and the Compliance Audit Report for January 2005 – December 2007.

Correspondence

The Board of Supervisors received a letter from the Northampton County Farmland Preservation Board of Directors requested their support of Act 4, which permits the freezing of the tax millage on preserved farms. All three taxing bodies (municipality, county, and school) must agree to the freeze. All Board members were in favor of the freeze. A motion was moved by Mr. Nagle and was seconded by Mr. Kucsan to authorize Mr. Tenges to discuss this with the other taxing bodies and report back to the Board. The motion carried.

Subdivision and Land Development

<u>Joseph I – Preliminary/Final Land Development – Resolution #LNT-08-09</u> – Attorney Michael Gavin was present on behalf of the Joseph family. This plan was previously approved with the bank pad in Palmer Township and the parking lot in Lower Nazareth Township; however this plan reverses the pads. The bank pad will be in Lower Nazareth and the parking lot in Palmer. Mr. Kortze reviewed his letter dated April 2nd recommending preliminary/final approval. A motion was moved by Mr. Johnson and was seconded by Mr. Nagle to approve Resolution #LNT-08-09. The motion carried.

Opus East – Revised Final Land Development – Resolution #LNT-09-09 – Jill Geist, Pany and Lentz, was present on behalf of Opus East. This project is located mostly in Bethlehem Township, but a portion is located in Lower Nazareth. Ms. Geist explained that some changes were being made to a previously approved plan, but those changes are only in the portion located in Bethlehem Township. Mr. Kortze reviewed his letter dated April 2nd recommending revised final approval. A motion was moved by Mr. Nagle and was seconded by Mr. Kucsan to approve Resolution #LNT-09-09. The motion carried.

Supervisor's Comments

Mr. Kucsan, Dr. Dilsaver, and Mr. Johnson had no comments.

Mr. Nagle, along with Mr. Kucsan, attended the CRPC meeting on March 23rd.

Manager's Report

ProLogis Parkway / Hollo Road Update — The Township has received numerous complaints from residents regarding the opening of Hollo Road. Mr. Tenges reported that he has been working with Mr. Kortze and Solicitor Asteak on this issue. First of all, ProLogis Parkway is a private road; it has not been turned over to township. Secondly, Mr. Tenges stated that he is looking out for the interest of Lower Nazareth Residents. Since development in Palmer Township (i.e. Majestic) will cause traffic to use Hollo Road to access Route 33, he wants inter-municipal agreement between Palmer and Lower Nazareth holding Palmer financially responsible for future improvements to that intersection. Mr. Tenges stated that keeping Hollo Road closed is a "bargaining chip" to get Palmer to the table.

In response to the comment from residents that a light be installed at Route 248 and Hollo Road; the township did ask PennDot about a light at that location and the request was denied.

Solicitor Asteak is preparing a draft agreement; hopefully in time for the next meeting.

<u>Hecktown Road Traffic Study</u> – Mr. Tenges discussed from a traffic study performed after a complaint and request from a resident to install stop signs along Hecktown Road at Saddle Drive, Presidential Drive, Green Pond Road, and Cobblestone Lane.

The study, which included review of motor vehicle accident reports, concluded that, based on the data, multi-way stop signs are not warranted; however does recommend the re-evaluation of the corridor if traffic patterns change in the future.

<u>Township Representation</u> – Mr. Tenges represented the township at the ribbon cutting at Kohl's and Firestone.

<u>Letter of Appreciation</u> – The Township received a letter of appreciation from Rosario Amato, Administrator of Athletics at Nazareth Area School District, for the use of Surrey Glen Park and for the support and assistance with the athletic program.

<u>Yard Waste</u> – It has come to our attention that East Penn Sanitation is no longer picking up yard waste from their customers. The office has been barraged with phone calls from residents wanting to know what to do with their yard waste. They have been offered information on our Yard Waste Program, however many want to get rid of grass clippings; which, at this time, we are unable to accept. We are exploring grass collection & storage requirements through DEP, however we are encouraging the residents to follow DEP's recommendation and "let it lay".

Mr. Tenges said that the next time we replace a truck; he is looking into one with an interchangeable body that would allow us to transport more yard waste to FRCA.

Mr. Tenges also discussed adapting the recycling ordinance and distributing the recycling cans.

Engineer's Report

Country Club Road Business Park – Letter of Credit Reduction – Mr. Kortze reviewed his letter dated April 2nd, recommending a reduction in security from \$649,833.88 to \$533,607.88. A motion was moved

by Mr. Johnson and seconded by Mr. Nagle to a \$116,226.00 reduction to the letter of credit. The motion carried.

Solicitor's Report

There were no items to discuss under Solicitor's Report.

Old Business

There were no items to discuss under Old Business.

New Business

There were no items to discuss under New Business.

Payment of the Bills

A motion was made by Mr. Kucsan and seconded by Mr. Nagle to approve the bills dated April 8, 2009. The motion carried unanimously.

There were no comments under Courtesy of the Floor.

Adjournment

A motion was moved by Mr. Johnson and seconded by Dr. Dilsaver to adjourn the meeting at 8:37PM.
