A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE **TOWNSHIP** OF LOWER NAZARETH. **COMMONWEALTH** NORTHAMPTON COUNTY, **AUTHORIZING** THE TOWNSHIP PENNSYLVANIA MANAGER TO APPLY FOR FUNDING THROUGH THE COMMONWEALTH FINANCING AUTHORITY'S MULTI-MODAL GRANT PROGRAM FOR THE PURPOSE OF OBTAINING FUNDING FOR THE ACQUISITION AND DEMOLITION OF PROPERTIES FOR THE WIDENING OF THE INTERSECTION OF NEWBURG ROAD AND STATE ROUTE 191.

WHEREAS, Lower Nazareth Township is a Second Class Township located in Northampton County, Commonwealth of Pennsylvania; and

WHEREAS, the Board of Supervisors of Lower Nazareth Township is responsible for the health, safety and welfare of the public; and

WHEREAS, in order to improve the safety of the traveling public, it is sometimes necessary to make certain road improvements, including the widening of intersections; and

WHEREAS, the intersection of Newburg Road and State Route 191 has been identified as in need of improved signalization and the addition of turning lanes, which requires widening of the intersection.

NOW, THEREFORE, BE IT RESOLVED, that the Township of Lower Nazareth of Northampton County hereby request a Mulimodal Transportation Fund grant of \$_545, 225 from the Commonwealth Financing Authority to be used for the purpose of acquisition of properties and demolition of buildings on the properties for the purpose of widening the intersection at Newburg Road and State Route 191.

BE IT FURTHER RESOLVED, that the Applicant does hereby designate Lori A. Stauffer, Township Manager as the official(s) to execute all documents and agreements between the Township of Lower Nazareth and the Commonwealth Financing Authority to facilitate and assist in obtaining the requested grant.
