WHEREAS, Lower Nazareth Township, prior to codification of the aforesaid provisions and the adoption of Act 2015-15, amending the Child Protective Services Law, undertook the responsibility for securing background certifications; and

WHEREAS, the aforesaid statute provides that employers, administrators, supervisors or other persons responsible for selection of volunteers shall require an applicant to submit to all requirements of the statute.

NOW, THEREFORE, IT IS HEREBY RESOLVED that the President or Chairperson of any organization conducting youth activities on Lower Nazareth Township property or using Township facilities shall provide a certification to the Lower Nazareth Township Manager, or his/her designee, certification of compliance with the aforesaid provisions of the Child Protective Services Law by way of annual report prior to receiving the necessary permits to use a Township facility, with a continuing obligation to update, modify, or amend the clearance of all individuals approved to conduct such activities.
