ORDINANCE NO. 233.02~9

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF LOWER NAZARETH TOWNSHIP PROHIBITING THE PARKING OF VEHICLES ON DESIGNATED STATE AND TOWNSHIP ROADS AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

BE IT ORDAINED AND ENACTED by the Board of Supervisors of Lower Nazareth Township, Northampton County, Pennsylvania, pursuant to the authority granted it under the Second Class Township Code, as amended, and the Vehicle Code, 75 Pa. C.S.A. 3353(d), having received an engineering and traffic study indicating that the stopping, standing and parking of vehicles would constitute a safety hazard and would unduly interfere with the free movement of traffic, as follows:

SECTION 1:

Section 7.15 of the Code of Ordinances of Lower Nazareth Township is hereby amended to provide as follows:

7.15 VEHICULAR PARKING PROHIBITED

- (A) Vehicular parking is prohibited as follows:
 - (1) In and along the public right-of-way of Christian Springs Road (T501);
 - (2) In and along the public right-of-way of Hollo Road (T499);
 - (3) In and along the public right-of-way of Georgetown Road (T483), commencing at its intersection with SR0248 and continuing southwesterly eight-tenths of a mile, more or less, to the common boundary line between Upper Nazareth Township and Lower Nazareth Township;

- (4) In and along the public right-of-way of SR0191;
- (5) In and along the public right-of-way of SR0248;
- (6) In and along the public right-of-way of SR0946 (a/k/a Daniels Road);
- (7) In and along the public right-of-way of Newburg Road (SR3020) for a distance of three hundred (300') feet east and west of its intersection with SR0191;
- (8) In and along the public right-of-way of Hecktown Road (TR438) east of Country Club Road (TR454) for a distance of one hundred fifty (150') feet as measured from the centerline of Country Club Road (TR454);
- (9) In and along the west side of the public right-of-way of Butztown Road (TR440) beginning at a point three hundred eighty-five (385') feet, as measured from the centerline of Schlegel Avenue (TR493) for a distance of one hundred fifty-seven (157') feet;
- (10) In and along the public right-of-way of Hecktown Road (TR438) from Country Club Road (TR454) to the common boundary line between Lower Nazareth Township and Palmer Township;
- (11) In and along the east side of the public right-of-way of Corriere Drive (TR606) from SR0248 to the common boundary line between Lower Nazareth Township and Palmer Township.

SECTION 2:

Section 7.16 of the Code of Ordinances of Lower Nazareth Township is hereby amended to provide as follows:

7.16 PENALTIES

Any person who shall violate the provisions of this Ordinance is guilty of a summary offense and shall, upon conviction, be sentenced to pay a fine of not more than Fifty (\$50.00) Dollars.

SECTION 3:

All Ordinances or portions thereof which are inconsistent with this Ordinance are hereby specifically repealed.

SECTION 4:

If any section, subsection, paragraph, sentence, clause or portion or part of this Ordinance shall be declared to be invalid or unconstitutional by any Court of record or competent jurisdiction then, in that event, the remaining portions of this Ordinance shall remain unaffected and remain in full force and effect.

SECTION 5:

This Ordinance shall be effective immediately.
