LOWER NAZARETH TOWNSHIP BOARD OF SUPERVISORS MINUTES January 27, 2021

The Lower Nazareth Township Board of Supervisors held a virtual meeting on Wednesday January 27, 2021. The Chairman called the meeting to order at 7:00PM.

Approval of Minutes

A motion was moved by Mr. Boucher and was seconded by Mr. Brown to approve the January 4th meeting minutes. The motion carried unanimously.

Reports (Reports are available to review at the Township Office and on our website.)

Mr. Pennington acknowledged the receipt of the Financial Report for December 2020 as well as the Hecktown Volunteer Fire Department Incident Reports for December 2020 and 2020 Totals. In addition, he acknowledged the receipt of the 4th Quarter ambulance reports from Bethlehem Volunteer Fire Company.

Supervisor's Comments

Mr. Pennington attended the monthly COG meeting with LVPC on the plan update. Estimated completion is mid-2021.

Mr. Hoyer attended the January 11th Environmental Advisory Council (EAC) meeting. The EAC has recommended against the Township taking over the open spaces proposed on the Colt's Run development map and that long term maintenance for these open spaces be the responsibility of the Colts Run HOA.

Ms. Templeton attended a library meeting on January 26th. The library is looking to partner with the Township for fundraising opportunities. The library director Holly sent her appreciation for the hard work of our Public Works Department with snow removal and salting of icy sidewalks.

Mr. Boucher attended the January 25th Colonial Regional Police Commission (CRPC) meeting. He commented they received numerous applications for the new officer position. Mr. Pennington added that he also attended the CRPC meeting.

Mr. Brown had no comments.

New Business

<u>Hecktown Volunteer Fire Company – Chief Seip – Pumper/Rescue Purchase</u> – Chief Seip made a brief presentation discussing the need for the new piece of apparatus and the funding plan to cover the \$854,268.00 cost. A motion was made by Mr. Boucher and was seconded by Ms. Templeton to agree to financially support the purchase of the new apparatus. The motion carried unanimously.

Conditional Use Hearing

<u>Central PA Equities 26, LLC (CU2020-06)</u> – Solicitor Asteak opened the hearing with a brief introduction. Attorney Blake Marles; David Hogg, Managing Partner of the Hotel; and Janet Miller of Liberty Engineering were present for the hearing.

Attorney Marles provided further introduction to the proposed project including adding a walkway from the hotel to the restaurant per the recommendation from the Planning Commission.

Mr. Hogg discussed the proposed restaurants, traffic, and landscaping.

Mr. Hoyer inquired about the serving of alcohol, the type of restaurant, public sewer, hours of operation, and lighting. Mr. Hogg stated they would be similar to an Applebee's, serve alcohol, be open 7 days, but not 24 hours, serviced by public sewer and noted there would be no light spillover.

Mr. Pennington inquired on the timeline. Mr. Hogg stated he hoped the project in completed and restaurants can open by the end of the year.

With no further questions from the Board or questions from the public, Solicitor Asteak closed the record. The Bord will render a decision and have the Opinion and Order for our February 10th meeting. He noted that the walkway would be a condition of approval.

Solicitor's Report

<u>Faust Family Limited Partnership</u>, No. 6 (CU2020-05) — Order and Opinion <u>Update</u> — Solicitor Asteak explained that upon request by the applicant, the Board discussed the amendment to its Opinion and Order. The amendment replaces the paragraph regarding the community center on page 10. A motion was moved by Mr. Hoyer and was seconded by Ms. Templeton to amend the Opinion and Order. The motion carried unanimously.

Amendment to Township Zoning Ordinance -

<u>Creation of Limited Light Industrial Overlay – Ordinance #237-01-21</u> – The applicant attended via Zoom and gave a brief presentation. A motion was moved by Mr. Brown and Ms. Templeton to approve Ordinance #237-01-21. The motion carried unanimously.

Engineer's Report

Sterling Crossing – Letter of Credit Reduction & Commence Maintenance Period – Mr. Kortze reviewed his January 21st letter recommending a \$252,869.10 reduction in security and to commence the 18-month maintenance period. A motion was moved by Mr. Boucher and was seconded by Ms. Templeton to reduce security and commence the maintenance period. The motion carried unanimously.

Hecktown Road Business Park #4 – Letter of Credit Reduction & Commence Maintenance Period – Mr. Kortze reviewed his January 21st letter recommending a \$555,951.55 reduction in security and to commence the 18-month maintenance period. A motion was moved by Mr. Hoyer and was seconded by Mr. Boucher to reduce security and commence the maintenance period. The motion carried unanimously.

Manager's Report

Manager's Report and Grant Update – Ms. Stauffer provided the Board with her monthly report and grant list. Since 2018, the Township has been awarded over \$1 million in grants. Our most recently awarded grants are a 90/10 DEP 902 grant from DEP in the amount of \$183,217.00. The 10% will be paid from our DEP 904 grant monies. In addition, we also just received notice of award of a CDBG grant in the amount of \$22,704.00 to pave the Senior Center Parking Lot which is in desperate need of repair.

Board of Supervisors Minutes January 27, 2021 Ms. Stauffer reported that we are awaiting a quote from Kratzer on the septic system repair at the Senior Center.

<u>Capital Equipment Purchase – Backhoe</u> – Ms. Stauffer requested authorization to proceed with the lease purchase of a new backhoe. The existing one will continue to be used until it no longer runs. A motion was moved by Mr. Boucher and was seconded by Mr. Brown to approve the lease purchase. The motion carried unanimously.

FRCA Agreement 2021-2023 – Ms. Stauffer requested authorization to enter into a three-year agreement with FRCA. The quarterly payments will be paid from our Recycling Account which is funded by DEP Performance Grants. A motion was moved by Mr. Boucher and was seconded by Mr. Brown to execute the agreement. The motion carried unanimously.

NC 2021 EMS Grant — Ms. Stauffer stated that Chief Seip would like to apply for the 2021 NC EMS Grant. In 2020, HVFC received funds to purchased training equipment. This year, Chief Seip would like to apply for equipment for the new truck they are purchasing. The maximum award for this grant is \$10,000 and it requires a dollar-for-dollar match. Ms. Stauffer is asking for authorization to provide a letter guaranteeing the match, a maximum of \$10,000, will be provided by the Township. The funds would come from the Capital Reserve Fire Account. A motion was moved by Ms. Templeton and was seconded by Mr. Hoyer. The motion carried unanimously. Ms. Stauffer reported that a decision is expected by March.

Newburg Inn Auction Results – Ms. Stauffer reported that the Township received a check in the amount of \$14,356.00 for he proceeds from the auction. An individual has made an offer of \$2,000 for the leftover items. Ms. Stauffer will draft an agreement and requested authorization to make arrangements with the individual for the removal of these items. A motion was moved by Mr. Boucher and was seconded by Ms. Templeton to authorize the agreement. The motion carried unanimously.

Payment of the Bills

A motion was moved by Ms. Templeton and was seconded by Mr. Boucher to approve payment of the bills dated January 27th. The motion carried unanimously.

Courtesy of the Floor

There we no comments under Courtesy of the Floor.
