LOWER NAZARETH TOWNSHIP BOARD OF SUPERVISORS MINUTES June 9, 2021

The Lower Nazareth Township Board of Supervisors held a virtual meeting on Wednesday June 9, 2021. The Chairman called the meeting to order at 7:00PM.

Approval of Minutes

A motion was moved by Ms. Templeton and was seconded by Mr. Brown to approve the May 26th meeting minutes. The motion carried unanimously.

Reports (Reports are available to review at the Township Office and on our website.)

Mr. Pennington acknowledged the receipt of the Financial Report for April 2021 and the Hecktown Fire Incident Report for May 2021.

Supervisor's Comments

Ms. Templeton reported that the rereati9n Committee met on June 8th. She stated that we received the grant for improvements to Hahn's Meadow and that work will be done in Spring 2022. She stated that Ms. Stauffer is looking to apply for the Healing the Plant grant through Giant in the amount of \$25,000.

The electric work for the generator at 306 Butztown Road has been awarded to MRP at a cost of \$6,638.00. Once Public Works installs the cement pad and the electrical work is completed the parking lot can be repayed.

Newburg Park updates - Ms. Templeton reported that construction of the dog park is moving along. The fence will be installed next week, with grading and hydro seeding to follow. She asked that everyone please avoid the area until ready. Mr. Kortze noted that MetEd is doing line study to see what power can be provided and he reaches out weekly for updates on the electric install to the site.

Mr. Brown commented that it is nice to have the public attending meetings in person again.

Mr. Hoyer commented that the EAC meets on June 14th at 7pm. He also stated that condition of Gradwohl Switch Road after the completed road work is good!

Mr. Pennington reported that the Multi Municipal Plan update continues. Their next meeting is Monday. They are hoping for completion by Fall. Mr. Pennington also provided positive comments of Gradwohl Switch Road.

Subdivision & Land Development

<u>Chipotle Improvements Agreement – Authorization to Execute</u> – A motion was moved by Ms. Templeton and was seconded by Mr. Brown to authorize the agreement be signed upon receipt of security and agreement signed by developer. The motion carried unanimously.

Solicitor's Report

Sanitary Sewer Agreements – Triple Net & LVTV II— Authorization to Execute – A motion was moved by Mr. Hoyer and was seconded by Ms. Templeton to authorize the agreements be signed upon receipt of security and agreement signed by developer. The motion carried unanimously.

Engineer's Report

<u>Trio Fields Phase 7 – Letter of Credit Release</u> – Mr. Kortze reviewed his letter dated June 4th recommending a \$130,109.10 reduction in the letter of credit. A motion was moved by Ms. Templeton and seconded by Mr. Brown to reduce the security. The motion carried unanimously.

Manager's Report

2021 Paving Project – Ms. Stauffer reported that Gradwohl Switch Road has been completed. The contractor will move on to Country Club Road later this month.

Eagle Scout Veterans Memorial – Ms. Stauffer reported that the project has been completed by Isaac Kutzura. Isaac has indicated that he successfully raised enough funds to cover the cost of the project therefore funding is now not needed from Township. He has asked that we donate funds to a veteran's organization. Mr. Pennington stated we could reimburse Isaac and he would be free to do what he wishes with those funds.

Open Space Preservation Application – Ms. Stauffer indicated that the Township received its first open space preservation application this afternoon. She requested the Board's authorization to forward the Rod and Gun Club's application to the Environmental Advisory Council (EAC) for review. A motion was moved by Ms. Templeton and was seconded by Mr. Brown to forward the application to the EAC. The motion carried unanimously.

In addition, she requested authorization for Township Engineer Al Kortze to provide a letter of review to the EAC. The cost is not to exceed \$1,000 and should contain, at a minimum:

- 1. Identify the soil types and classes on the property by percentage
- 2. Identify zoning classification
- 3. Identify the areas of the property where floodplain exists
- 4. Identify if the property has a particular designation on the official map
- 5. Identify any existing environmental features on the property (woodlands, streams, wetlands)
- 6. Identify any additional factors you may discover about the property that may be pertinent to the EAC's review

A motion was moved by Ms. Templeton and was seconded by Mr. Brown to authorize the Township Engineer to draft the letter for the EAC. The motion carried unanimously.

<u>Park Benches – Authorization to Purchase</u> – The benches will be placed at Surrey Glen and Newburg Community Park. Ms. Stauffer reported that we have been advised by the vendor that if the order is not placed by June 11th the cost will increase by 30%. The cost of the benches will be offset by resident park donations, A motion was moved by Mr. Brown and was seconded by Ms. Templeton to authorize the purchase of the park benches. The motion carried unanimously.

Board of Supervisors Minutes June 9, 2021 <u>Public Works Equipment – Authorization to Purchase</u> – Ms. Stauffer requested authorization to purchase the Bobcat 5600 for the recycling facility. The COSTARS price is \$56,714.41. Ms. Stauffer noted that 90% of the cost will be funded by a DEP 902 grant, with the 10% balance covered with DEP 904 funds. A motion was moved by Mr. Hoyer and was seconded by Mr. Brown to authorize the purchase. The motion carried unanimously.

Payment of the Bills

A motion was moved by Mr. Brown and was seconded by Ms. Templeton to approve payment of the bills dated June 9th. The motion carried unanimously.

Courtesy of the Floor

Matt Connolly is a GC for an individual looking for a home and interested in buying land on Gradwohl Switch Road. Mr. Connolly wants homes that are 55+ ranch style homes. The land is currently zoned agricultural therefore he would need a zoning change. He requested feedback from the Board. Mr. Pennington said the Township is in a pause at this time. The Township is getting lots of requests for zoning changes, so we are taking a time out until Multi-Municipal Plan has been updated. The woman wishing to build a home was upset that this was not revealed when they met with Township a few weeks ago. Ms. Stauffer commented that the Board had not made the determination at that time. Once decided, the email was sent to Mr. Connolly.
