A RESOLUTION AUTHORIZING THE TOWNSHIP MANAGER TO MAKE APPLICATION TO THE MONROE COUNTY LOCAL SHARE ACCOUNT ON BEHALF OF LOWER NAZARETH TOWNSHIP FOR THE PURPOSE OF PROVIDING FUNDING FOR UPGRADES AND IMPROVEMENTS TO TOWNSHIP OWNED TRAFFIC LIGHTS

WHEREAS, Lower Nazareth Township is a community consisting of approximately eight square miles with a population of 6,922 people; and

WHEREAS, the Board of Supervisors of Lower Nazareth Township recognizes their responsibilities under the Second Class Township Code to provide for public roadways in the Township in order to facilitate traffic flow throughout the community; and

WHEREAS, the Board of Supervisors of Lower Nazareth Township recognizes their responsibilities to provide adequate and up-to-date traffic signage and traffic lights to promote the orderly flow of traffic, which will protect the health, safety and welfare of our residents and those who visit our community; and

WHEREAS, the Lower Nazareth Township Director of Public Works has recommended replacement of various traffic light components to several Township-owned traffic lights to maintain optimal functionality and provide for various technology upgrades; and

WHEREAS, the replacement and upgrade of traffic light components will allow the Township to continue facilitating proper traffic flows and enhancing the safety of the traveling public.

BE IT RESOLVED, that the Lower Nazareth Township, Northampton County Pennsylvania hereby request a Monroe County Local Share Account grant of \$\limes \limes \frac{1}{2} \limes \frac{500}{000}\$ from the Commonwealth Financing Authority to be used for the purpose of providing funding for the replacement of various traffic light components and the provision of various technological upgrades for the safety of the traveling public.

BE IT FURTHER RESOLVED, that the Applicant does hereby designate Lori A. Stauffer, Township Manager as the official to execute all documents and agreements between Lower Nazareth Township, Northampton County, Pennsylvania and the Commonwealth Financing Authority to facilitate and assist in obtaining the requested grant.
