RESOLUTION NO. LNT-33-21

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP **OF** LOWER NAZARETH, NORTHAMPTON COUNTY, **COMMONWEALTH OF** PENNSYLVANIA AUTHORIZING THE **TOWNSHIP** MANAGER TO PUBLICLY ADVERTISE CERTAIN PIECES OF TOWNSHIP EQUIPMENT FOR SALE PURSUANT TO THE SECOND CLASS TOWNSHIP CODE, SECTION 1504

WHEREAS, Lower Nazareth Township is a Second Class Township in the Commonwealth of Pennsylvania governed by the Second Class Township Code and the laws of the Commonwealth; and

WHEREAS, the Board of Supervisors of Lower Nazareth Township have authorized the purchase of certain pieces of equipment and tools for the purpose of conducting Township business; and

WHEREAS, the lifespan of the equipment and tools has a limit where the equipment and tools become worn or obsolete; and

WHEREAS, Article XV of the Second Class Township Code (Act of May 1, 1933 (P.L. 103, No. 69) as amended, Section 1504 prescribes the manner in which the Board of Supervisors may sell equipment and tools that are deemed worn or obsolete.

NOW, THEREFORE BE IT RESOLVED on this 10th day of November, 2021, the Lower Nazareth Township Board of Supervisors adopts this resolution and resolves the following:

- (1) The Board of Supervisors of Lower Nazareth Township authorizes the Township Manager to dispose of certain equipment and tools of the Township as listed in "Exhibit A"
- (2) The sale of the equipment and tools shall be in accordance with Section 1504 of the Second Class Township Code. A public advertisement shall be made requesting bids from the public. Bids shall be due no later than a specific date and time as prescribed in the public advertisement. Interested parties shall be afforded the opportunity to inspect the equipment and tools prior to placing a bid. Once all bids are received, the bids shall be voted on by the Board of Supervisors to accept or reject the bids.

- (3) All sales of the equipment shall be final, and all equipment is sold "AS IS" with no express or implied warranty provided by Lower Nazareth Township.
- (4) Once the Board of Supervisors accepts a bid, the Township Manager is further authorized to take the necessary steps to proceed with the sale.

DULY ADOPTED on this 10th day of November, 2021 at a duly advertised public meeting and by a majority of the entire Board of Supervisors of Lower Nazareth Township.
