LOWER NAZARETH TOWNSHIP BOARD OF SUPERVISORS MINUTES February 9, 2022

The Lower Nazareth Township Board of Supervisors held a hybrid meeting on Wednesday, February 9, 2022. Chairman James Pennington called the meeting to order at 7:00 PM.

Agenda Amendment and Approval

Ms. Stauffer requested to add a resolution to authorize application to a grant program under her reports. Mr. Pennington requested to add recognition of Officer Kovach who will be retiring next month.

A motion was moved by Mr. Hoyer and was seconded by Mr. Boucher to approve the amended February 9th meeting agenda. The motion carried unanimously.

<u>CRPD Recognition</u> — Mr. Pennington presented a proclamation to Officer Kovach. Officer Kovach joined Colonial Regional Police Department on February 10, 1997. He has served for 25 years as a Colonial Regional Police Officer. Officer Kovach will retire on March 3, 2022. The week of March 7th will be Officer Kovach week in Lower Nazareth Township.

<u>Conditional Use Hearing - CU2021-02 Franklin BioScience - Decision</u>

Solicitor Asteak reviewed the Order and Opinion. A motion was moved by Mr. Brown and was seconded by Mr. Boucher to approve the Opinion and Order. The motion carried unanimously.

Approval of Minutes

A motion was moved by Ms. Templeton and was seconded by Mr. Boucher to approve the January 26th meeting minutes. The motion carried unanimously.

Mr. Pennington acknowledged the receipt of the January 2022 Hecktown Fire Incident Report.

Supervisor's Comments

<u>Multi-Municipal Plan Update</u> – Mr. Pennington noted there is a NAZCOG meeting next week. He reported we are closer to having a draft ready for review.

Open Space Preservation – Mr. Hoyer reported that the EAC meets February 14th at 7pm.

<u>Parks & Recreation</u> – Ms. Templeton had nothing to report under Parks and Recreation. She did want to thank you the Public Works Staff for their efforts with the Township Line Road closure during the storm last Thursday into Friday. Thank you!

Ms. Templeton also reported that she, along with Ms. Stauffer and Jeff Shepard met with the library. The library discussed their renovation plans. The project is estimated to cost \$2.9 million dollars but will not be paid from general operating funds. The project will be completed in 8 phases. Funding will come from grants, fund raisers, and donations.

Mr. Brown had no comments.

Mr. Boucher had no comments.

Subdivision & Land Development

LVTC III - Presentation - 4733 Hanoverville Road/Dutch Springs site

Present in person were Attorney Catherine Durso, Matthew Nunn, Trammell Crow Company, John Wichner, McMahon Transportation Engineers and Planners (Traffic Engineer), and Mike Jeitner, Bohler Engineering (Civil Engineer).

Mr. Nunn discussed the latest proposal which includes keeping the quarry active. They received a proposal to continue to use lake for diving by a local diving group, Dive, LLC.

The applicant noted they have received required variances from both Bethlehem and Lower Nazareth Townships.

Mr. Jeitner discussed the two-building proposal. There will be three lots; Building A will be on lot one, Building B will be on lot two, and the diving will be on lot 3. Total area is roughly 100 acres. One building will be located in Lower Nazareth and the other in Bethlehem Township. Access will be along Hanoverville Road. Access for diving facility will also be off Hanoverville Road. In addition, they will be providing a bike path along Hanoverville Road.

The applicant Proposing to connect to sewer through BT. Intermunicipal Agreement with BT and LNT.

Mr. Wichner and Attorney Durso discussed coordinating efforts with Petrucci on widening of Hanoverville.

Mr. Kortze discussed previous coordination between Trammel Crowe and ProLogis on the other end of Hanoverville Road. Coordinated efforts allows for the improvements to be made and only repave road once. He reviewed his February 4th letter including his comments on the 10 requested waivers.

Waivers A-E – Solicitor Asteak stated since they are technical drafting waivers they can be approved together. A motion was moved by Ms. Templeton and was seconded by Mr. Boucher to grant waivers A-E. The motion carried unanimously.

Waiver F - SALDO Section 749.1. Mr. Hoyer inquired about the bike path versus curbing and sidewalk. Mr. Jeitner stated given the pedestrian activity a bike path makes sense A motion was moved by Ms. Templeton and was seconded by Mr. Hoyer to grant waiver F. The motion carried unanimously.

Waivers G-I – Solicitor Asteak stated since they are storm drainage waivers they can be approved together. A motion was moved by Ms. Templeton and was seconded by Mr. Hoyer to grant waivers G-I. The motion carried unanimously.

Waiver J – SALDO Section 733.33 - A motion was moved by Mr. Brown and was seconded by Mr. Boucher to grant waiver J. The motion carried unanimously.

Mr. Pennington was concerned about trucks drivers using GPS and wanting to take the shortest route. However the bridge over Monocacy has weight restriction and the Route 191 and Hanoverville intersection is not constructed for trucks traffic. He asked for the applicant's thoughts to help keep traffic where it should be and not in areas prohibited to truck traffic. Attorney Durso noted her discussions with Solicitor Asteak on providing additional payments to Lower Nazareth.

Mr. Wichner discussed additional signage including PADOT approved solar power lighted signs on the property indicating no right turn.

Mr. Pennington discussed the need for sufficient onsite and overnight parking. Mr. Wichner and Mr. Jeitner showed the staging and storage areas on the site plan.

Mr. Pennington inquired about the placement of the guard shack. Mr. Jeitner showed there is room available for two, in the event there are two tenants. There is also room available for a guard shack for scuba operations as well.

Mr. Pennington inquired about a snow clearing tools for trucks. Mr. Nunn stated that would be tenant driven but they could look into that. Mr. Pennington stated they should have an agreement with tenants.

Mr. Pennington inquired about LANTA/bus service on site for employees that do not have a vehicle. Attorney Durso stated that is up to LANTA if they would want to expand service. JP Brodhead has service. Solicitor Asteak stated that perhaps the Township could approach LANTA. Mr. Nunn stated that the bridge may be an issue for buses. Ms. Seese stated that she recently spoke with Ms. Wood from LANTA and there is currently no plans to expand service because of the bridge.

Mr. Boucher wanted to ensure that Hecktown Fire would maintain access to quarry/lake.

Solicitor Asteak inquired about restroom facilities for drivers? Mr. Nunn stated that is tenant driven. Solicitor Asteak thought they should consider provisions in the lease to allow for access to drivers to use facilities in building.

Mr. Brown inquired on the process for someone wanting to use diving facility. A representative from Dive, LLC stated this will be more of a training facility and limited to professionals/trained individuals. He also noted that access would be with timed tickets.

Mr. Pennington stated the Board would defer their decision to the March 9th meeting. Solicitor Asteak is unavailable for our next meeting on February 23rd.

Attorney Durso asked for authorization for Solicitor Asteak to draft letter to communicate to Bethlehem Township and Bethlehem Township Municipal Authority about sewer allocation and intermunicipal agreements.

Board of Supervisors Minutes

A motion was moved by Mr. Boucher and was seconded by Ms. Templeton to authorization the communication. The motion carried unanimously.

Solicitor Asteak state he would provide Attorney Durso with the approval resolution sent prior to the meeting for their review.

3758 Hollo Road Subdivision - Resolution #LNT-10-22

Sue Kandil, of Penn Technology Consulting gave a brief presentation on the proposed subdivision. Mr. Kortze reviewed his Feb 2nd letter. He recommended approving the deferral of road widening until the future development of lots 1 & 2. He told the applicant to reach out to Chris Noll about septic testing on the site.

Mr. Hoyer inquired about the deferral. Mr. Kortze once the owner of the property returns with a plan then the road widening would be required. Depending on what the plan is will determines the required width.

A motion was moved by Ms. Templeton and was seconded by Mr. Brown to approve the Resolution #LNT-10-22. The motion carried unanimously.

Solicitor's Report

<u>Authorization to Execute Sales Agreement with Notaro</u> –Solicitor Asteak noted that we possess a signed agreement. A motion was moved by Ms. Templeton and was seconded by Mr. Boucher to authorize execution of sales agreement with Notaro. The motion carried unanimously.

<u>Authorization to Execute Sales Agreement with Fulton Bank</u> – Solicitor Asteak noted that we have reached an agreement and it is currently with Fulton for execution. A motion was moved by Ms. Templeton and was seconded by Mr. Boucher to authorize execution of sales agreement with Fulton Bank. The motion carried unanimously.

<u>Authorization to File Subdivisions for Notaro and Fulton Bank Properties PC and LVPC review and waive fees</u> — A motion was moved by Ms. Templeton and was seconded by Mr. Brown to authorize filing of subdivision plans for Notaro and Fulton Bank Properties. The motion carried unanimously.

Engineer's Report

Mr. Kortze reported he has submitted the subdivision plans to LVPC.

Manager's Report

<u>Time Extension Report</u> – Ms. Stauffer noted that the Township accepted a time extension for Keystone Foods through June 22, 2022.

Commonwealth Financing Authority – Local Share Account – Grant Application – Resolution #LNT-11-22 – Ms. Stauffer proposed applying for a grant to the Commonwealth Financing Authority for the replacement of stormwater pipe on Butztown Road and pavement overally from the intersection of Route 191 and the township line. The cost estimate for the project is \$570,382.75.

She asked authorization to apply for the grant and to designate Mr. Pennington and herself as the officials to execute all documents and agreements between the Township and Commonwealth Financing Authority. JP and LAS resp for signing documents commonwealth financing authority

A motion was moved by Mr. Brown and was seconded by Ms. Templeton to approve the Resolution #LNT-11-22. The motion carried unanimously.

Payment of the Bills

A motion was moved by Ms. Templeton and was seconded by Mr. Hoyer to approve payment of the bills dated February 9th.

<u>Courtesy of the Floor</u>

Jeff Shepard thanked the Board for the markers placed on the fire hydrants. He also questioned whether the sidewalk could be extended to the park entrance along Gremar Road. Ms. Stauffer stated that this could be done.
