**RESOLUTION NO. LNT-23-22**

**A RESOLUTION AUTHORIZING THE TOWNSHIP  
MANAGER TO MAKE APPLICATION TO THE  
GREENWAYS, TRAILS AND RECREATION  
PROGRAM ON BEHALF OF LOWER NAZARETH  
TOWNSHIP FOR THE PURPOSE OF FURTHER  
DEVELOPING NEWBURG COMMUNITY PARK  
WITH A SPLASH PAD, MAINTENANCE  
BUILDING, FENCING, AND A PAVILION.**

**WHEREAS**, Lower Nazareth Township owns a 88-acre parcel that is currently an community park under construction; and

**WHEREAS**, the Board of Supervisors of Lower Nazareth Township desires to continue developing the property as a community park for the benefit and enjoyment of the community; and

**WHEREAS**, as part of the continued development of the community park, the Board of Supervisors of Lower Nazareth Township desires to create a community park that will be utilized by people of all ages and abilities; and

**WHEREAS**, Phase IV of the development includes the installation of a 71' x 75' splash pad, 500 sq. foot maintenance building, a 20' x 40' pavilion and fencing with ADA-compliant pathways to make accessibility easy for people of all abilities;

**WHEREAS**, it is proposed that the splash pad will have an ADA-access path and the equipment installed shall be ADA-compliant;

**BE IT RESOLVED**, that the Lower Nazareth Township, Northampton County Pennsylvania hereby request a Greenways, Trails and Recreation Program (GTRP) grant of \$150,000.00 from the Commonwealth Financing Authority to be used for the purpose of installing a splash pad, maintenance building, pavilion and fencing.



Stauffer, Township Manager as the official to execute all documents and agreements between Lower Nazareth Township, Northampton County, Pennsylvania and the Commonwealth Financing Authority to facilitate and assist in obtaining the requested grant.


