## LOWER NAZARETH TOWNSHIP BOARD OF SUPERVISORS MINUTES March 23, 2022

The Lower Nazareth Township Board of Supervisors held a hybrid meeting on Wednesday, March 23, 2022. Chairman James Pennington called the meeting to order at 7:04 PM.

Present were:

#### **Agenda Amendment and Approval**

A motion was moved by Mr. Boucher and was seconded by Mr. Brown to approve the March 23<sup>rd</sup> meeting agenda. The motion carried unanimously.

### **Approval of Minutes**

A motion was moved by Mr. Hoyer and was seconded by Mr. Brown to approve the March 9th meeting minutes. The motion carried unanimously.

### Reports

The financial report for February 2022 was submitted for Board review.

### **Supervisor's Comments**

<u>Multi-Municipal Comprehensive Plan</u> – Chairman Pennington announced the LVPC will be presenting the draft plan at the April 18<sup>th</sup> Planning Commission meeting.

Open Space Preservation – Supervisor Hoyer reported the EAC had a presentation by Environmental Planning & Design at the March meeting. He also reported the EAC is hoping to organize a tree-planting event at Surrey Glen Park.

Parks & Recreation - Supervisor Templeton reported on the following:

- 1. Newburg Park The Township will be applying for funding for the splash pad and pickleball courts in order to continue the development of this park.
- 2. Surrey Glen Park The contractor will be coming back in the beginning of April to complete the work on the trail. We are still waiting for some of the playground equipment prior to installation. Once these two items are completed, we can close out the Livable Landscapes grant.
  - 3. Hahn's Meadow The Township will be going out to bid soon for the stream overlook.
  - 4. Everyone has been working hard on the upcoming Easter Egg Hunt, which will be on April 9th at 11:00 a.m.

Supervisor Boucher reported Lower Nazareth Township will be hosting Coffee with a Cop on April 12<sup>th</sup> from 8:00 a.m. to 10:00 a.m.

#### Subdivision and Land Development

- 1. <u>Triple Net Planning Module</u> Resolution LNT-14-22 was presented for review and discussion. The resolution pertains to the sewage planning module for Triple Net's land development plan located at the intersection of Hanoverville Road and Georgetown Road. Mr. Hoyer made a motion to adopt Resolution LNT-14-22. Ms. Templeton seconded. Motion passed.
- 2. <u>LVTC III Planning Module</u> Resolution LNT-15-22 was presented for review and discussion. The resolution pertains to the sewage planning module for LVTC III's project on the former Dutch Springs property. Mr. Boucher made the motion to adopt Resolution LNT-15-22. Mr. Brown seconded. Motion passed.
- 3. <u>LVTC III Intermunicipal Cooperation Agreement</u> The draft agreement represents an intermunicipal cooperative effort between Lower Nazareth Township and Bethlehem Township Municipal Authority. LVTC III is proposing to utilize the Bethlehem Township Municipal Authority for sewage disposal for the building that will be in Lower Nazareth Township. Mr. Hoyer made a motion to authorize the Chairman to execute the agreement on behalf of Lower Nazareth Township. Ms. Templeton seconded. Motion passed.
- 4. <u>First Park Land Development Plan</u> The intent of the project is to construct a 145-space parking lot at 3902 Eastgate Blvd. for the exclusive use of the warehouse located at 3895 Eastgate Blvd. The Lower Nazareth Township Planning Commission recommended conditional final approval at their January 17, 2022, meeting. Township Engineer Kortze reviewed his letter dated March 21, 2022. A draft resolution was presented outlining the conditions of approval. Mr. Brown made a motion to adopt Resolution LNT-16-22. Mr. Boucher seconded. Motion passed.
- 5. <u>2685 Opus Way Phase 2 Parking Lot Improvements</u> The intent of the land development plan is to create an additional 75 parking spaces and installation of underground stormwater detention facilities. Majority of the improvements will occur in Bethlehem Township. The land development plan was reviewed by the Lower Nazareth Township Planning Commission on February 28, 2022, and they recommend final conditional approval. Township Engineer Kortze reviewed his letter dated March 17, 2022. A draft resolution was presented outlining the conditions of approval. Mr. Brown made a motion to adopt Resolution LNT-17-22. Mr. Hoyer seconded. Motion passed.
- 6. Gensits Lot Line Adjustment The intent of the plan is the separation of approximately 31,784 square feet from the adjoining Lower Nazareth Township Rod & Gun Club property and merging the area with property owned by Mary Lou Gensits (L6-18-7A). The lot line adjustment plan was reviewed by the Township Planning Commission at their February 28, 2022, meeting and they recommended granting final conditional approval. Township Engineer Kortze reviewed his letter dated February 2, 2022. A draft resolution was presented outlining the conditions of approval. Mr. Boucher made a motion to adopt Resolution LNT-18-22. Mr. Hoyer seconded. Motion passed.
- 7. <u>Kelly Nissan Land Development Plan</u> The intent of the plan is to construct a 7,350 square foot service building to the rear of the property located at 3830 Easton-Nazareth Highway. The land development plan was reviewed by the Township Planning Commission at their February 28, 2022, meeting and they recommended conditional final approval. Township Engineer Kortze reviewed his letter dated March 16, 2022. A draft resolution outlining the conditions of approval was presented. Mr. Hoyer made a motion to adopt Resolution LNT-19-22. Mr. Boucher seconded. Motion passed.
- 8. Fulton Bank, N.A. Minor Subdivision The intent of the subdivision plan is to subdivide and convey approximately .10 acres to Lower Nazareth Township for the purpose of future intersection widening. The subdivision plan was reviewed by the Lower Nazareth Township Planning Commission on February 28, 2022, and they recommended conditional final approval of the plan. As Keystone Consulting prepared the subdivision plan, an alternate engineer was utilized for the review. Justin Coyle of Carroll Engineering reviewed his letter dated February 24, 2022. A draft resolution outlining the conditions of approval was presented. Mr. Hoyer made a motion to adopt Resolution LNT-20-22. Mr. Boucher seconded. Motion passed.

9. Notaro Minor Subdivision – The intent of the subdivision plan is to subdivide and convey a total of .1658 acres to Lower Nazareth Township for the purpose of future intersection widening. The subdivision plan was reviewed by Lower Nazareth Township Planning Commission at their February 28, 2022, meeting and they recommended granting conditional final approval. As Keystone Consulting prepared the subdivision plan, an alternate engineer was utilized for the review. Justin Coyle of Carroll Engineering reviewed his letter dated February 24, 2022. A draft resolution outlining the conditions of approval was presented. Mr. Boucher made a motion to adopt Resolution LNT-21-22. Mr. Hoyer seconded. Motion passed.

### **Engineer's Report**

Mr. Kortze reported he has completed the restoration plan for the Clemis property. He will reach out to Mr. Clemis to review it with him.

#### Manager's Report

Ms. Stauffer requested the items pertaining to the roof and HVAC for the Ambulance Corps. Building be tabled until a future meeting.

<u>2022 Road Projects</u> – Ms. Stauffer reported the Township accepted sealed bids for the 2022 road project work that was advertised. In response, the Township received one bid from AMS in the amount of \$379,461.17. This is above the \$342,000 estimate that was discussed during budget in October; however, since them the price of oil has skyrocketed. Mr. Hoyer made a motion to award the 2022 Road Project contract to AMS (Asphalt Maintenance Solutions) in the amount of \$379,461.17. Mr. Boucher seconded. Motion passed.

306 Butztown Road Parking Lot – The Board previously authorized the public bid for the work to mill and overlay the Senior Center parking lot. Bids were received and the lowest, qualified bidder is Delaware Valley Paving for a cost of \$67,150.60, which is within the cost estimate for the project. Ms. Stauffer also reminded the Board that the Township received a grant for \$22,704 for this project. Mr. Boucher made a motion to award the contract to Delaware Valley Paving at a cost of \$67,150.60. Mr. Brown seconded. Motion passed.

Emergency Operations Plan – A revised EOP was received from Assistant EMC/Fire Chief Seip. Mr. Hoyer made a motion to adopt Resolution LNT-22-22. Ms. Templeton seconded. Motion passed.

Greenways, Trails and Recreation DCED Grant — The Board previously requested Ms. Stauffer to apply for additional funding for the Newburg Park Splash Pad project. She reported the Board will need to adopt a resolution as part of the grant application package. A draft resolution authorizing Ms. Stauffer to make application to the GTR program for funding for a splash pad. Mr. Brown made a motion to adopt Resolution LNT-23-22. Ms. Templeton seconded. Motion passed.

<u>Livable Landscapes Grant Resolution</u> – The Recreation Committee has recommended the Board of Supervisors consider applying for funding through the Livable Landscapes program for the construction of pickleball courts at Newburg Park. A resolution needs to be submitted as part of the grant package. A draft resolution was provided for Board review and discussion. Mr. Brown made a motion to adopt Resolution LNT-24-22. Ms. Templeton seconded. Motion passed.

Nazareth Area Baseball/Softball Request – Ms. Stauffer explained the Township received a request from NABSA for the use of our facilities at 306 Butztown Road for a day long community event. Adam Anthony appeared and discussed the planning for the event. Mr. Brown made a motion to authorize the use of 306 Butztown as requested under the conditions that the organization is respectful to the surrounding neighbors and obtains the necessary insurance information for all vendors. Mr. Hoyer seconded. Motion passed,

### Payment of the Bills

A motion was moved by Mr. Boucher and was seconded by Ms. Templeton to approve payment of the bills dated March 23<sup>rd</sup>. Motion passed.

## **Courtesy of the Floor**

Margaret Mazziotta of 431 Nazareth Pike questioned if the intersection project will impact their property. Mr. Kortze responded it shouldn't be an issue as the work is being shifted towards the bank area.

Gary Reed of 491 Nazareth Pike appeared to express concern about surveying work that is being conducted on the old Faust Farm. He also had questions on the Miklos property.

Adjournment - The meeting adjourned at 7:55 PM.
