

**TOWNSHIP OF LOWER NAZARETH  
NORTHAMPTON COUNTY, PENNSYLVANIA**

**ORDINANCE NO. 270-06-22**

**AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF  
LOWER NAZARETH TOWNSHIP ESTABLISHING STOP INTER-  
SECTIONS, SPEED LIMITS, AND PARKING REGULATIONS ON  
MIKRON ROAD WITHIN THE TOWNSHIP OF LOWER NAZARETH.**

BE IT ENACTED AND ORDAINED by the Board of Supervisors of Lower Nazareth Township, Northampton County, Pennsylvania, and it is enacted and ordained by the authority of same, pursuant to the Second Class Township Code, as amended, and Vehicle Code, as amended, as follows:

**SECTION 1:**

Section 7.21 of the Code of Ordinances of Lower Nazareth Township is hereby amended to add the intersections set forth below:

**7.21 STOP INTERSECTIONS**

The following intersections are hereby established as stop intersections, and official stop signs are hereby confirmed as officially erected at the following locations controlling traffic on the first named road, erected on the first named road at its intersection with the second named road, in the direction or directions hereby indicated. All vehicles and tractors approaching any such intersection upon the first named highway in the direction or directions hereby indicated in each case, shall come to a full stop, within a reasonable distance before entering any such intersection:

- a. On Mikron Road at PA Route 191, southwest corner of the intersection, sign facing west
- b. On Mikron Road at Mikron Road, northwest corner of the intersection, sign facing north

**SECTION 2:**

Section 7.15 of the Code of Ordinances of Lower Nazareth Township is hereby amended to add the following:

7.15 VEHICULAR PARKING PROHIBITED

- (A) Vehicular parking is prohibited as follows:
- (1) On the south side of Mikron Road; 160 feet west of PA Route 191; sign facing west
  - (2) On the east side of Mikron Road; 680 feet west of PA Route 191; sign facing south
  - (3) On the south side of Mikron Road; 880 feet west of PA Route 191; sign facing west
  - (4) On the north side of Mikron Road; 900 feet west of PA Route 191; sign facing east
  - (5) On the south side of Mikron Road; 1,050 feet west of PA Route 191; sign facing west
  - (6) On the west side of Mikron Road; 1,250 feet west of PA Route 191; sign facing north
  - (7) On the east side of Mikron Road; 1,270 feet west of PA Route 191; sign facing south
- (B) A two-hour temporary truck parking exemption is hereby established on Mikron Road as follows:
- (1) On the north side of Mikron Road; between a distance of 450 feet and 530 feet west of PA Route 191; signs facing east
  - (2) On the south side of Mikron Road; between a distance of 450 feet and 550 feet west of PA Route 191; signs facing west

**SECTION 3:**

Section 7.51 of the Code of Ordinances of Lower Nazareth Township is hereby amended to add as follows:

**7.51 SPEED LIMITS**

The following named and described sections of Lower Nazareth Township roads and/or highways are hereby posted by the Township with the below mentioned speed limits at the below described physical locations:

<u>ROAD</u>	<u>FROM/TO</u>	<u>MPH SPEED LIMIT</u>
Mikron Road	PA Route 191/end	25

Speed limit signs shall be posted as follows:

- a. 25 MPH speed limit sign on the north side of Mikron Road; 90 feet west of PA Route 191; sign facing east
- b. 25 MPH speed limit sign on the south side of Mikron Road; 550 feet west of PA Route 191; sign facing west
- c. 25 MPH speed limit sign on the east side of Mikron Road; 50 feet north of Mikron Road intersection; sign facing south

**SECTION 4:**

All Ordinances or portions thereof which are inconsistent with this Ordinance are hereby specifically repealed.

**SECTION 5:**

If any section, subsection, paragraph, sentence, clause or portion or part of this Ordinance shall be declared to be invalid or unconstitutional by any Court of record or of competent jurisdiction then, in that event, the remaining portions of this Ordinance shall remain unaffected and remain in full force and effect.

**SECTION 6:**

This Ordinance shall be effective immediately.
