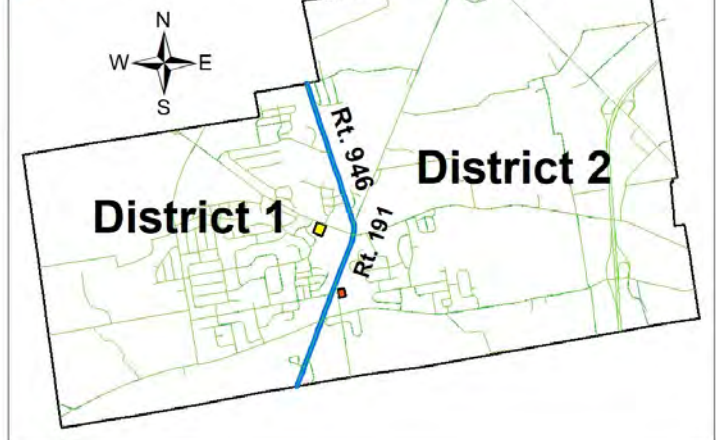

ROUTE 191 & NEWBURG ROAD INTERSECTION UPDATE

As many of our residents are aware, Lower Nazareth Township has partnered with PennDOT for this project. Lower Nazareth agreed to procure the necessary right-of-way for the widening project. PennDOT will handle the actual construction. The Township has been working diligently to procure the necessary right-of-way. At this time, the Township has secured three corners and is in negotiations with the fourth corner. There is no eminent domain being utilized at this time. The Board is working towards amicable agreements with all parties.

PennDOT is proposing left-turning lanes with signalized left-turn traffic lights. They have extended the scope of the project to include the intersection of Route 191 and Route 946 (Daniels Road), which will include a traffic signal. .

The timeline for this project is as follows:

- * 2023 Preliminary Design
- * 2024 Environmental Study
- * 2025 Final Design
- * 2026 Start of Construction

The right-of-way acquisition and building demolition is funded through traffic impact fees, which are fees charged to developers for land development in the Township.

The Board is excited as this project continues to move forward as the widening and improvement of this intersection has been necessary for a long time!

SPRING ELECTRONICS RECYCLING EVENT

Our 2022 electronics recycling event was even more popular than the one held in 2021. We filled two trucks and recycled nearly 10 tons of material. The total cost of the event was \$1,694.00 and was covered 100% by Northampton County. We received many positive comments from the residents!!

LOWER NAZARETH TOWNSHIP'S FIREWORKS ORDINANCE

Lower Nazareth Township has adopted an ordinance which strictly prohibits the ignition or discharge of fireworks except during certain dates and times.

Lower Nazareth Ordinance #231-01-19: Section 12B states that the ignition or discharge of Consumer Fireworks is strictly prohibited except during the following dates and times:

Memorial Day 4:00PM—11:00PM

July 3rd 4:00PM—11:00PM

July 4th 4:00PM—11:00PM

July 5th 4:00PM—11:00PM

Labor Day 4:00PM—11:00PM

December 31st 4:00PM—11:00PM

January 1st 12:00AM—12:30AM

January 1st 4:00PM—11:00PM

BOARD OF SUPERVISORS CORNER

SNOW REMOVAL ORDINANCE

For the protection, health, safety, and welfare of the community the Board adopted ordinance #238-05-21. The entire ordinance is available on our website www.lowernazareth.com. The ordinance addresses snow removal from sidewalks, private/non-public roads, the clearing of fire hydrants, and throwing, shoveling, or plowing snow onto roads, streets, and sidewalks.

SIDEWALKS - All snow, slush, and ice, along the full width of the sidewalk and across driveways shall be removed within 24 hours after the end of the storm.

PRIVATE / NONPUBLIC STREETS - No more than four inches (4") of snow or slush shall accumulate or ice shall accumulate to a degree that makes the street impassable or unsafe for travel.

THROWING, SHOVELING, PLOWING SNOW ONTO ROADS, STREETS, OR SIDEWALKS - No one shall throw, shovel, push, or plow snow into, across, or upon any roads, streets or sidewalks.

FIRE HYDRANTS - All snow, slush, and ice are to be cleared from fire hydrants within 24 hours after a storm or once in every 24 hours period during a storm.

Specifically, a three foot (3') wide path from the street to the fire hydrant and a three foot (3') wide circle around the fire hydrant shall be cleared for access by the fire department.

It is in everyone's best interest to keep hydrants accessible in the event of a fire. Please assist a neighbor that may need help removing snow from around a hydrant on their property.

ENFORCEMENT & PENALTIES - Anyone that violates any provision of the ordinance is subject to fines.



IMPORTANT INFORMATION ON DETENTION PONDS

It is a misconception that detention ponds are owned by the Township. The property owner is responsible for the maintenance of the detention pond that is on their property. At a minimum, maintenance includes mowing, clearing of debris, and sinkhole repair.

In addition, detention ponds are private property. They are meant to control stormwater runoff and are not for recreation/play. Please instruct your children to stay out of the detention ponds.

REMINDER ABOUT ROADSIDE BASKETBALL HOOPS



A reminder to everyone that both portable and permanent basketball structures, along and within township roads and right-of-ways, are not permitted as it promotes recreational activity in the street. This is a very dangerous practice. These structures are classified as accessory structures and while they are permitted on the same lot as the principal use, they are not allowed within the township right-of-way. Please abide by this restriction as we don't want anyone to get hurt.

FINANCIAL CORNER

REAL ESTATE TAXES

Township residents will receive **three** real estate tax bills each year. Lower Nazareth Township receives 4.50 mills of tax and Northampton County receives 10.80 mills levied on real estate in the Township. The Nazareth Area School District's real estate tax levy is 56.80 mills. For example, a Township resident with a real estate valuation of \$100,000 in 2022 will pay a total of \$3,637.50 in real estate taxes distributed as follows:

LOWER NAZARETH TOWNSHIP REAL ESTATE TAX COLLECTOR

Lower Nazareth Township Real Estate tax bills are issued each year in February and cover the calendar year (January through December).

Township resident, Eric Mitcheltree was elected to the position of Real Estate Tax Collector. As of July 2019, Mr. Mitcheltree is **ONLY** collecting the Lower Nazareth Township Real Estate Taxes. If you do not receive or misplace your tax bill, please contact Mr. Mitcheltree at 484-291-1546. The **Lower Nazareth Township Tax Collector's Office** remains closed to the public due to the pandemic. Please mail all payments to the address on your tax bill. If you must pay in person please call to make arrangements. The Tax Collector's phone number is 484-291-1546.

When mailing your payments, it is important that you provide your phone number on your check. If there is an issue with your payment, you can be contacted in order to correct the problem so that your payment is received on time. If you want a receipt, include both bill copies along with a self-addressed, stamped envelope. If you have any questions, please call 484-291-1546 and the tax collector will be able to assist you. NAZARETH AREA SCHOOL DISTRICT REAL ESTATE TAX COLLECTOR

Nazareth Area School District Real Estate tax bills are issued each year in July and are for the school's fiscal year (July of current year through following June). Berkheimer Associates is the collector for school taxes. Payments are made payable to HAB-MISC and can be mailed to PO Box 25144, Lehigh Valley, PA 18002-5144. If you have any questions, please call 610-559-3143 for assistance.

PROPERTY TAX RELIEF—Residents of the Nazareth Area School District may be eligible for a property tax rebate under programs administered by the district. For more information, please contact Representative Ann Flood's district office at 610-746-2100 or Senator Mario Scavella's district office at 610-863-1200. Staff will be happy to help you determine your eligibility and fill out the appropriate paperwork.

NORTHAMPTON COUNTY REAL ESTATE TAXES

Northampton County Real Estate tax bills are issued each year in January and cover the calendar year (January through December). Northampton County collects their own taxes. Payments are made payable to County of Northampton and can be mailed to PO Box 25008, Lehigh Valley, PA 18002-5008 or paid in person at Fulton Bank (previously Lafayette Bank).

EARNED INCOME TAXES & OPEN SPACE PRESERVATION

In the Primary Election in May 2019, residents voted in favor of a .25% increase to the Earned Income Tax for Open Space Preservation. In August 2019, the Board of Supervisors adopted an ordinance to increase the earned income tax for that purpose. Therefore, as of January 2020, the earned income tax rate is 1.45%. The additional .25% collected will be segregated into a separate fund, which can be used only for open space preservation.

EARNED INCOME TAXES



One of Lower Nazareth Township's largest source of local revenue is our 1.45% earned income tax, which is split as .7% for the Nazareth Area School District, .25% Open Space Preservation, and .5% for the Township.

Local income tax in Pennsylvania is based upon where you live rather than where you work. Individuals who are self-employed or whose employer doesn't withhold the full 1.45% are required to pay it directly. Penalties will be added if not paid quarterly.

Lower Nazareth Township requires all persons moving into, out of, or within the Township to apply for a Moving Record. Securing a Moving Record allows the Township to document your moving date and forwarding address. This updated information makes processing your tax documents more convenient for you. The fee for a Moving Record is \$5 and may be secured at the Township Office during normal business hours.

Taxpayers with earned income in 2022 are required to file a Final Tax Return by **Tuesday April 18, 2023**. If you live and work in Pennsylvania, you can [e-file](#) on our tax administrator's secure website, which is available 24/7 at www.KeystoneCollects.com.

Keystone Collections Group's [e-file](#) is the easy, fast and secure way to file your 2022 tax return. You will need your W-2, your Social Security Number, and any other income documents that may apply (such as a PA-UE or a Schedule C)

LOCAL SERVICES TAX

Local Services Tax is collected at the Township Office. Residents that are self-employed and work out of their homes are required to pay the \$52.00 annual tax as long as they make \$12,000.00 or more. Self-employed residents that earn less than \$12,000.00 or have a full-time job outside of Lower Nazareth Township that is withholding the Local Services Tax is required to submit an Exemption Form on an annual basis. ROUTE 191 WATER SYSTEM IMPROVEMENTS

On Monday, August 22, 2022, Easton Suburban Water Authority's Contractor, Joao and Bradley, Inc., began a project to install new water main on Route 191 between Newburg Road and Christian Springs Road in Lower Nazareth Township. The project will consist of installing a new 12" ductile iron water main and then installing copper water service laterals from the new water main. The water system work will begin at the intersection of Christian Springs Road and Route 191 and proceed south on Route 191 to the intersection with Newburg Road.

The construction of the water system improvements will be done in four phases. The first phase will consist of the installation of the new water mains. Once the new water mains have been installed and tested, the second phase will consist of replacing the existing service laterals and connecting them to the new water main. This will cause an interruption in service to customers of approximately two to four hours when the service lateral to their property is connected to the new water main.

The third phase will be the connection of the new water mains to the existing water mains on the side streets as needed. This may cause an interruption in service of approximately six to eight hours for those customers on the streets adjoining the project area.

The final phase of the project will be the restoration of the pavement and other disturbed areas. The trenches will be temporarily restored when the water system work is completed with final restoration being performed once the trenches have been provided with adequate time to settle. The Authority anticipates the water system work will be completed by the end of October.

Most of the construction will be performed during daytime hours, with work beginning at 7:00AM and lasting until approximately 5:00PM. There are portions of the water system work that must be performed at night as required by the Pennsylvania Department of Transportation. The night work includes 5 crossings of Route 191 at the intersections with Christian Springs Road, Lonat Drive, Daniels Road, and Newburg Road and at 467/471 Nazareth Pike. The night work will be performed between approximately 6:00PM and 6:00AM. We will work with our Contractor and PennDOT to minimize the night work as much as possible.

NEW NAZARETH AREA SCHOOL DISTRICT SUPERINTENDENT



Dear Lower Nazareth Township Residents,

I have been in public education since 1993, first serving as a social studies teacher in the Montoursville Area School District and then as a high school, middle school, and elementary school administrator for the next nineteen and a half years. Additionally, I was an Athletic Director, High School Basketball Coach, and Student Government Advisor.

In terms of my educational background, I am a 1988 graduate of Wyoming Valley West High School in Plymouth, Pennsylvania. My undergraduate education was at Temple University where I received a Bachelor of Science Degree in Secondary Education Social Studies. My Masters' Degree in Educational Leadership comes from Lehigh University and my Doctor of Education is through Widener University.

In partnership with Lower Nazareth Township, NASD has an important mission to provide a learning environment for each student to fulfill their highest academic potential and prepare each student to become an independent, responsible, and caring citizens. I am confident that through our partnership, our dedicated staff, and our exceptional students and families, we will continue to grow and provide the best opportunities for our children and their future.

NASD attracted me for two primary reasons. The first was that I always wanted the challenge of leading a large school district, working alongside a strong administrative team for the betterment of staff and students. The second reason was the area's rich history, combined with its blue-collar roots, reminded me of where I grew up in Northeastern Pennsylvania. As a Social Studies teacher, I knew Nazareth and the surrounding municipalities were once a very prosperous industrial region producing cement, steel, textiles, and of course, Martin Guitars. SURREY GLEN PARK IMPROVEMENTS



Construction of the walking trail and the installation of playground equipment is complete.

The Township has received numerous positive comments on the improvements made to this park.

Lower Nazareth Township was awarded a \$100,000 Northampton County Livable Landscapes grant for the installation of a walking trail and playground at Surrey Glen Park.

In addition, Lehigh Valley Health Network (LVHN) donated funds towards the completion of the walking trail.



AMBULANCE BUILDING IMPROVEMENTS

Last November, The Board of Supervisors authorized repairs to the ambulance building located at 4519 Hanoverville Road, currently leased by Bethlehem Township Ambulance Corps. The authorized repairs include replacement of the existing roof and replacement of the existing HVAC units.

Lower Nazareth Township has committed to paying the matching costs for these repairs as part of the Northampton County EMS grant that was awarded to Bethlehem Township Volunteer Fire Company. The grant was in the amount of \$46,000.

The roof replacement was completed in May 2022 and cost \$56,420.00; \$28,210.00 was covered by the grant. The HVAC work is scheduled to be completed this Fall.

NORTHAMPTON COUNTY SENIOR CENTER

In May, repairs to the parking lot at 306 Butztown Road was completed by Delaware Valley Paving. The total cost for the repairs was \$70,150.60. The Township received a Northampton County CDBG grant in the amount of \$22,704 towards the cost of the project.



NEWBURG PARK UPDATES

The Township is continuing to make progress with our projects at the Newburg Community Park.

PARK SIGNAGE

The Township has installed the digital sign for the park along Newburg Road. The sign will be updated regularly to inform everyone of upcoming events in the Township. The Board authorized the purchase of two additional signs. One will be “Newburg Park” and installed at the entrance on Greemar Road. The other will be a sign that will include a map of the Township along with plaques listing names of the donors that helped make the improvements to Newburg Park possible. We are hopeful that both will be ready and installed in time for Dog’s Day Out at the end of October!

OPENING OF LOWER NAZARETH’S DOG PARK

The dog park consists of two sections; one for dogs under 25 pounds and the other for dogs over 25 pounds. The Township is finishing up the unique features for the dog park like fire hydrants and other water features. The Lower Nazareth Township Board of Supervisors will be hosting the grand opening of the Dog Park on Saturday, October 22nd from 11:00AM to 4:00PM. The event will include food vendors, rescues and retail vendors. The first 100 dogs will have a chance receive a goody bag and all attendees can play to win an awesome prize. Read the article on the front cover for more details. We hope to see you there!

PICKLEBALL COURTS

Pickleball popularity has been soaring in the Lehigh Valley. The Board applied for a Northampton County Livable Landscape Grant in the amount of \$48,445.50. Despite not being awarded the grant, the Board decided to move forward with plans to add pickleball courts to our park amenities in response to our residents requests for appropriate courts to play the sport. The project was put out to bid this summer and will be awarded this September. We are hopeful the courts can be installed before year end.

YARD WASTE RECYCLING PROGRAM



The Township offers several organic waste recycling programs to our residents. These programs provide an outlet for our residents to dispose of their organic waste and in return reap the benefits of the programs by utilizing the mulch and compost derived from the recycling process. The programs are outlined below.

YARD WASTE RECYCLING

All persons participating in the program will be required to provide identification at the time of disposal or pick up.

Acceptable Material: BRUSH AND COMPOST ITEMS SHALL BE KEPT SEPARATE.

Brush (natural/untreated): 8-inch diameter max and no longer than 8 feet; bushes – No Roots Please!

Compost Items: Hedge trimmings, garden residue & leaves – loose or in brown paper bags. NO PLASTIC BAGS!

Unacceptable Material: Grass clippings*, ornamental grass, sod, soil, straw or hay, and plastic bags!

*Lower Nazareth Township supports the position of the State Department of Environmental Protection and strongly recommends recycling your grass clippings by using a mulching mower. Please visit the DEP website for more information on this topic.

Special Instructions: All material must be thoroughly checked for any foreign objects (nails, wire, stones, etc.). Material with debris will not be accepted as it may harm the processing equipment!

BY-PRODUCTS / MULCH AND COMPOST

When available, a supply of the mulch and compost products derived from the FRCA recycling process will be on hand. We strongly encourage our residents to utilize these products.

First Regional Compost Authority (FRCA) – In addition to our local program, a secondary drop off site known as the First Regional Compost Authority (FRCA) is available for Township Residents to utilize.

The facility is located at 6701 Weaversville Road, Northampton, PA 18067. The FRCA operates under its own schedule. Current hours are listed on their website www.frcaweb.org. Hours are subject to change. Please call 610-262-1000 to confirm hours and for any questions.

» Important note about refrigerated units:

*** All refrigerated appliances must be de-freonized by a certified technician and tagged accordingly. Appliances without tags will not be accepted.** Examples of appliances containing refrigerant are refrigerators, coolers, de-humidifiers and air conditioners.

Some tips on preparing your material for disposal:

- ◆ separate any plastic and metal parts from toys, household items, etc.
- ◆ remove glass from storm doors and windows
- ◆ clean all wood products of foreign material (nails, drywall, etc.)

We thank you for your cooperation and look forward to a successful Clean-up Day!

MANDATORY CURBSIDE RECYCLING

Curbside recycling collection is mandatory for all residential properties and commercial establishments throughout the Township. Lower Nazareth Township has notified known trash haulers of the recycling requirements. If you are uncertain if your hauler collects recyclables, please contact them directly. Source separation and preparation for recycling of the materials is up to the hauler. The recycled materials shall be separated from regular trash and placed at the curb or prescribed area for collection.

The Township ordinance establishes a minimum list of required recyclables. Those items are:



- ◆ Clear, brown and green glass
- ◆ Aluminum and bi-metal (tin cans) containers
- ◆ Plastic containers:
 - Pet no. 1: soft drink, water, salad dressing containers, etc.
 - HDPE no. 2: milk jugs, juice bottles, detergent, motor oil containers, etc.
- ◆ Newspapers, corrugated paper (boxes), cardboard (cereal box, etc.), and magazines

Although our ordinance does not mandate recycling of plastic numbers 3, 4, 5, 6, and 7 it is your option to recycle those items if your hauler accepts them. Some examples are:

- ◆ **V(vinyl) or pvc no. 3:** window cleaner, detergent bottles, shampoo bottles, cooking oil bottles
- ◆ **LDPE(low density polyethylene) no. 4:** squeezable bottles; bread, frozen food, and shopping bags
- ◆ **PP (polypropylene) no. 5:** yogurt containers, syrup bottles, ketchup bottles, caps, straws, medicine bottles
- ◆ **PS (polystyrene) no. 6:** disposable plates and cups, meat trays, egg cartons, carry-out containers,
- ◆ **Miscellaneous no. 7:** three and five-gallon water bottles, and certain food containers

RECYCLING CONTAINERS

Every residential property is entitled to (2) recycling containers. A majority received their containers in the initial distribution in 2010. If you have not received your container, you may pick one up at the Township Office, Monday through Friday between the hours of 7:30AM and 3:30PM. Second containers are available and may be picked up during the same times. **Please note: recycling containers are issued for the residence. When you move, containers are to be left for the new home owners.**

It is not mandatory to use a Township provided recycling container. The only requirement is that any container used for recycling shall be clearly marked 'RECYCLABLES' with letters being at least 4" high and the font be at least ½" wide. This is so the hauler can easily identify the recycling container.

TOWNSHIP LEAF COLLECTION PROGRAM



The program will begin on demand sometime between the middle of October and the middle of November. Actual collection will commence when a sufficient amount of leaves have fallen to warrant dispatching the collection equipment. The program will continue through December as conditions warrant. Residents of Lower Nazareth Township are required to abide by the following regulations governing leaf collections.

Leaves are to be recycled through the Township's collection program. Residents must place their leaves along the edge of the street or curb for the Township to collect. It is the responsibility of the residents to protect their leaves along the street so they do not blow throughout the neighborhood. Leaves will not be collected on private property. In addition, collection crews will not rake piles of leaves out from between or under parked cars. Collection crews will not empty plastic bags or containers; this is the responsibility of the resident. Branches, grass clippings, shrubbery, garbage and building material will not be collected. These items will be left behind, and are the responsibility of the resident. Please do not use bricks, rocks, etc. to hold tarps on top of your leaf pile. They may inadvertently get mixed into the pile and subsequently vacuumed into the machine. These objects will severely damage the machine and may cause catastrophic failure of the equipment.



With the increasing number of maturing trees each year in various areas of the Township, it is impossible to guarantee a specific pick-up day for any one location. If the leaves are not in place when the crew goes by, they will be picked up on the next rotation. This schedule is subject to inclement weather, mechanical breakdown, and Township emergencies, requiring Public Works Department personnel and equipment to be reassigned. Your area could be skipped at any time should these situations occur.

TOWNSHIP CHRISTMAS TREE RECYCLING PROGRAM

This program is only for residents of Lower Nazareth Township.

All persons participating in the program will be required to provide identification at the time of disposal.

Special Instructions: Please remove any ornaments, tinsel and tree bags when disposing the trees to prevent potential damage to the chipping equipment.

MAKE YOUR HOME THE SOLUTION FOR STORMWATER POLLUTION!

As stormwater flows over driveways, lawns, and sidewalks, it picks up debris, chemicals, dirt, and other pollutants. Stormwater can flow into a storm sewer system or directly to a lake, stream, river, wetland, or coastal water. Anything that enters a storm sewer system is discharged untreated into the waterbodies we use for swimming, fishing, and providing drinking water. Polluted runoff is the nation's greatest threat to clean water.

By practicing healthy household habits, homeowners can keep common pollutants like pesticides, pet waste, grass clippings, and automotive fluids off the ground and out of stormwater. Adopt these healthy household habits and help protect lakes, streams, rivers, wetlands, and coastal waters. Remember to share the habits with your neighbors!



VEHICLES & GARAGE:

- ◆ Wash your car on a lawn or other unpaved surface to minimize the amount of dirty, soapy water flowing into the storm drain & eventually into your local waterbody.
- ◆ Check your car, boat, motorcycle, & other machinery & equipment for leaks & spills. Clean up spilled fluids with an absorbent material like kitty litter or sand, & don't rinse the spills into a nearby storm drain.

LAWN & GARDEN:

- ◆ Set your mower height to 3 inches or higher. Taller grass slows the runoff and produces a deeper and denser root system, which absorbs more water and prevents erosion. Deeper roots also reduce the need for watering during droughts and suppress weeds from growing up around them.
- ◆ Use pesticides & fertilizers sparingly.
- ◆ Do not fertilize or use pesticides within 15 to 20 feet of a stream. Keeping this distance will help keep chemicals out of waterways.

HOME REPAIR & IMPROVEMENT:

- ◆ Properly dispose of excess paints through a household hazardous waste program.

PET CARE:

- ◆ When walking your pet, remember to pick up the waste & dispose of it properly. Flushing pet waste is the best method.

SWIMMING POOL & SPA

- ◆ Drain your swimming pool only when a test kit does not detect chlorine levels.


SEPTIC SYSTEM USE & MAINTENANCE

- ◆ Have your septic system inspected by a professional at least every 3 years, & have the septic tank pumped as necessary.

HECKTOWN VOLUNTEER FIRE COMPANY



2022 has been a busy and exciting year for the fire company. The Hecktown Volunteer Fire Company has responded to over 225 calls for service while striving to maintain our training and recruitment efforts. We took delivery of our newest piece of apparatus in April and have continued to move forward with improvements to our facilities.

On April 1st members of the truck committee traveled to the 4-Guys

Fire Trucks plant in Meyersdale, PA to inspect and take



delivery of our new pumper rescue truck, 5341. This truck will serve a dual purpose as our primary rescue unit for auto accidents and other rescues as well as being a front line pumper with a 1750-gallon per minute pump and a 1,000-gallon water tank. The anticipated service life of this truck is twenty to thirty years. Lower Nazareth Township was instrumental in providing funding and securing grants to cover the cost of this new apparatus.

This year we will host our annual open house on October 3rd, from 6:30PM— 8 PM. This is an excellent opportunity to come out and meet our firefighters, see all of the apparatus and learn more about our all-volunteer operation. There will be opportunities for every to learn more about fire safety and participate in some hands-on learning activities. Refreshments will be provided.

Our annual Santa's Toy Run fundraiser will take place on December 10th. Santa will be visiting homes in Lower Nazareth Township starting at 10AM. Additional information will be provided via our Social Media accounts. We will also be posting signs around the Township as a reminder.

Please remember to test your smoke and carbon monoxide detectors once a month and replace the batteries twice a year. Any units over 10 years old should be replaced. New models are available with 10 year lithium ion batteries that last for the entire life of the smoke or carbon monoxide detector.

As we continue to experience severe weather events, please take time to make sure that you have an adequate supply of food and water stored for your family. If you know that your home is prone to flooding, a sump pump is an important tool in reducing damage and protecting your investment. Home generators are also becoming more popular. Please remember to install and use them in compliance with the manufacturers directions and have them installed and serviced by a licensed contractor. Never operate a generator inside your home, garage, or on an enclosed patio.

OPIOID EPIDEMIC & RECOVERY ASSISTANCE

The Colonial Regional Police Department recognizes that the misuse of Opioids in the United States is of epidemic proportions. Opioid misuse and addiction in some way affects every household in America. The members of the Colonial Regional Police Department have partnered with the Bethlehem Health Bureau to take an active and compassionate role in helping people deal with opioid and other drug addictions.

The Colonial Regional Police Department is the latest police department in Northampton County to offer a program that connects heroin and opioid addicts to treatment. CPAIR (Colonial Police Assisting in Recovery) is modeled after the ANGEL program developed by the Gloucester Police Department. This program is unique in that it brings law enforcement, drug and alcohol treatment providers and individuals seeking treatment together in an effort to reduce heroin and opioid use. Funding for the program was provided by a grant from the Pennsylvania Commission on Crime and Delinquency.

CPAIR allows an individual struggling with a drug addiction to walk into the Colonial Regional Police Department between 8:00AM-12midnight and ask for assistance. The police department will then arrange for a professional to complete a drug and alcohol intake assessment and assist with finding a treatment facility. A peer recovery support specialist will also be provided to support the individual during the recovery process.

NORTHAMPTON COUNTY'S GUN BUYBACK EVENT

The Northampton County District Attorney's Office is holding its first Gun Buyback event on Saturday, Oct. 1st from 10AM to 2PM with the assistance of the Colonial Regional Police Department, City of Bethlehem Police Department, Hecktown Fire Company, and the Bethlehem City Fire Department.

The event will be held rain or shine and is entirely anonymous. County residents do not need to show proof of ID. Residents will receive payment ranging from \$50 to \$200 in grocery gift cards based upon the condition of each weapon.

Residents are asked to safely transport their firearms – unloaded and in the trunk of their vehicle to either drop off location:

Hecktown Fire Company, 230 Nazareth Pike in Bethlehem
Bethlehem City Fire Department, 2412 Easton Avenue in Bethlehem

Rifles, handguns, shotguns, and semi-automatic weapons will be accepted. Ammunition is also accepted but not for payment.

Once the firearm is surrendered, it becomes the property of the police department. All guns go through a ballistic test to see if any are evidence in unsolved crimes. If so, those will be retained as evidence, while all other weapons will be destroyed.

ZONING ADMINISTRATOR'S CORNER

What about a **Driveway Permit**? Yes, Driveway Permits are required. Any time you repair, repave (overlay), or reconstruct your driveway, you must apply for a Driveway Permit. Conformity with the Zoning Ordinance will be checked and we will also make sure that roadside swales and drainage are maintained. Many times homeowners want to eliminate the swale in their driveway; however, those swales help the water get where it needs to go.



Working from home? In the past year, working from home has become more common. Lower Nazareth Township requires a **Zoning Permit** for a Home Office. Home Offices are permitted in most zoning districts. A Home Office use would be limited to persons who are permanent residents of the dwelling, visitors limited to less than 5 per day, no parking or use of trucks on the lot or street, using less than 25% of their dwelling, and no sign identifying the business. Anything more than this is considered a Home Occupation, which requires Special Exception approval from the Zoning Hearing Board. The cost of the Zoning Permit for a Home Office is a one-time fee of \$50.00. The application form can be found on our website.



In general, **Open Burning is prohibited in Lower Nazareth Township**, which includes burn piles, burning barrels, etc. Burning is generally only allowed for:

Solely for Cooking Food
Agricultural Operations
Prevention of a Hazard

Firefighter Training
Disease or Pest Control
Ceremonial Purposes

Burning Permits are typically only issued for agricultural operations.

These days a lot of people have **outdoor kitchens, fireplaces or firepits**. We want to stress the following points when we talk about fire safety:

- * Your neighbors may not enjoy the smoke blowing into their yard or they may have asthma which makes it harder for them to breathe. Please always be considerate of your neighbors and keep your fire small. The bigger the fire, the greater the potential for disaster.
- * Always keep your fire pit at least 10 feet away from any structure or combustible surface.
- * Before lighting an outdoor fire, check the weather forecast. Avoid windy conditions that can blow embers.
- * Stay up to date on any burn bans that might be in effect at different times during the year.
- * Picking up leaves and other combustible materials, around the pit is important to ensure the fire doesn't accidentally spread.
- * Always have a container of water nearby and a garden hose on standby before starting the fire.



New Alarm System? – Yes, you need a permit for that, too. *Why?* **Alarm Permits** are necessary to register systems to the homeowner. In the event that there is a call to 911, Police and Emergency Services will respond. Sometimes, it is a false alarm. If no one is home, we need to know who to contact. Police and Emergency resources are often wasted by alarm systems that are not functioning properly or simply human error. Excessive false alarms are a waste of valuable resources and tax dollars. The Township's Alarm Ordinance does provide for the ability to issue fines for false alarms; however, everyone's time would be better served by making sure your systems are functioning properly. The Alarm Permit application can be obtained in the Township Office or on the Township's website. The cost of the permit is a one-time fee of \$10.00.

KNOX BOXES FOR RESIDENTIAL PROPERTIES



In Lower Nazareth Township, most commercial buildings are equipped with Knox Boxes as required by Ordinance. A Knox Box is a small, wall-mounted safe that holds building keys for firefighters and EMT's to retrieve in emergencies. The Knox Boxes are linked via radio to the dispatch station, where the dispatcher can release the keys with DTMF tones allowing emergency response personnel to quickly enter a building without having to force entry. Knox Boxes cut fire losses for building owners since firefighters can enter buildings without breaking doors or windows.

In Lower Nazareth Township, residential properties are not required to have a Knox Box; however, they are available. If you are frequently out of town or unavailable for an emergency at your home, a Knox Box allows emergency personnel access your property. If you are interested in a residential Knox Box, please contact the Township Office.

DISPLAY YOUR HOUSE NUMBER

Where is your house? I can't find it!

When you look at your home from the street, the most important item you should see is your house number. The delivery man or the person delivering your dinner are not the only people that need to find your house easily. In the event of an emergency, Police, Fire and Ambulance services must be able to find your house quickly, day and night. Your house number should be prominently displayed on your house – not just your mailbox. The numbers should also be reflective or backlit in order to be seen clearly at night. Reflective numbers can be purchased for a few dollars at any home improvement store. Please make sure your house number is visible from the street – It might save your life! (*Zoning Ordinance Article 16, Section 1614*)

MOVING RECORDS



What is a **Moving Record** and why do I need one? A Moving Record is really a record of who is living at a particular property. We collect the names of all individuals 18 years or older moving in, out or within Lower Nazareth Township for earned income tax collection purposes. The Moving Record can be obtained in person at the Lower Nazareth Township Municipal Building. The cost of the Moving Record is five dollars (\$5). At the time a Moving

Record is completed, new residents will also receive a "New Resident Packet" which provides lots of helpful information about living in Lower Nazareth Township. In addition, you may also pick up two recycling cans if they haven't been distributed yet for that property.

SELLING YOUR HOME?

Lower Nazareth Township has not adopted a property maintenance code; therefore, the Township does not require a new Certificate of Occupancy for the resale of existing residential property or for a change in tenancy. However, please remember to complete a Moving Record!

RENTAL DISCLOSURE ORDINANCE



If you own real estate and you currently rent your property or plan to do so in the future, please be aware that every real estate owner who rents or leases all or part of their property is required to provide the Township with a list of all adults who have rented from them for the prior 6 months. It is important for property owners to follow through with providing this information to insure fair and impartial collection of earned income taxes.

FREQUENTLY ASKED QUESTIONS

18045, 18020, 18064 - I'm confused - Am I Lower Nazareth Township resident?

Yes, you are! Many people who move to Lower Nazareth Township get confused about where they live just because of their zip code, and that is understandable. It can be unclear with so many municipalities having similar names. In some larger cities or towns it is common for the municipality to have its own zip code. However, in Lower Nazareth Township we do not have our own zip code. Mail delivery in Lower Nazareth is routed and delivered from (3) different zip codes: Easton, 18045; Bethlehem, 18020; and Nazareth, 18064. Even though you have one of these zip codes, you are still a resident of Lower Nazareth Township.

Does Lower Nazareth Township enforce covenants or deed restrictions?

No, Lower Nazareth Township only enforces its own laws and ordinances. Covenants or deed restrictions are enforced by the property owners in a subdivision or a Homeowner's Association (HOA). We always suggest you review your deed or consult your HOA whenever you are considering an improvement to your property. The Township may approve a permit for fence or shed; however, your HOA may restrict that improvement in another way, such as color, placement or aesthetics.

I'm doing renovations and I need to get a dumpster – Can I store it on the street?

We do not allow dumpsters or storage pods to be stored on the streets in Lower Nazareth Township. You must store them on your own property, outside the public right-of-way.

POPULAR NEW PET – BACKYARD CHICKENS

These days, it seems everyone wants to have chickens to get their own eggs. Fowl permitted in the Township are: chickens, ducks, geese or similar birds. Limitations are as follows:

Property Less than (2) acres: ONLY (2) birds

Property More than (2) acres: No more than (6) birds.

In all cases, they must be kept on your own property at all times. If you have more than (3) they must be kept a minimum of 75 feet from your neighbor's dwelling.



HELPFUL TIPS FROM THE SEWAGE ENFORCEMENT OFFICER

For some residents, they are familiar with what needs to be done to maintain their septic system; however, for others septic maintenance is new to them. On-lot septic systems present considerable operation and maintenance responsibilities. We ask that you are kind to your system and remember the following tips:



- ✓ Protect the primary septic area and the replacement absorption area from earth disturbance.
- ✓ Keep traffic, equipment, sheds, pools, etc. off your septic tanks and drain fields.
- ✓ Have your system checked bi-annually by a competent septic system contractor.
- ✓ Have your tank pumped every 2-3 years, or as needed.
- ✓ Conserve water and avoid heavy peak loads to the system.
- ✓ Space laundry loads out over a few days if possible.
- ✓ Do not dispose of any paper, cloth or fibrous products into your system (cigarettes, diapers, etc.)

Snow Removal Policy and Practice

At the very beginning of a snowfall it is the departments policy to start with salting and cindering of all roads as to keep the snow from bonding to the road and allows the plows to better scrape the road surface. When it is necessary the department will begin plowing.

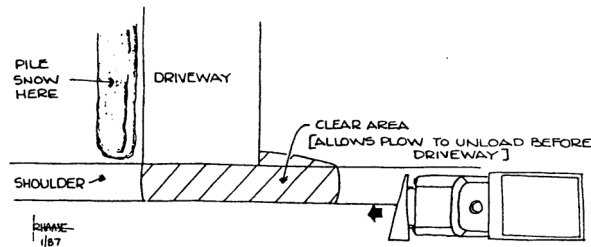
It is the Township's policy to first plow the main roads and then the secondary or development roads. This procedure helps to facilitate the flow of higher volumes of traffic and allows emergency vehicles access to the entire Township as quickly as possible. During larger storms the department may only make 2 passes (one in each direction in center of road) in developments to allow emergency vehicles access as main roads may require more attention. The department will return after the storm is over to push the snow back to the curb, grass, driveways on main roads and developments. Please keep in mind that if you live on Route 191, Route 248, Route 946 or Newburg Road these are roads that are maintained and plowed by the state.

Your patience is greatly appreciated

Snow removal is a tedious and time-consuming process. Our crews work long hours, in adverse conditions and under stress to keep our roads safe for you and the public. It is never the operator's intentions to damage a mailbox or hit your yard. It is impossible for the operator to avoid pushing snow into your driveway, if you must clear your driveway prior to the completion of snow plowing keep in mind that you will have to clear your driveway again. Our operators while plowing attempt to maintain speeds of no more than 20mph. The force of snow being thrown from a plow at this speed creates an illusion that the truck is going faster than what it is. Please refrain from calling asking about when your street is going to be plowed. We will get to every location as quickly as possible. Each operator is assigned a route and typically starts that route at the same point every storm. Barring no breakdowns or staff shortages the department can have ALL township roads plowed curb to curb in approximately 6-7 hours after the snow is done falling. A wave or a thumbs up to the passing operator goes a long way. After hours of plowing they too will most likely have to go home, and shovel or snow blow their own driveway out from a passing plow.

Shoveling Tips

When clearing your driveway, place the shoveled snow on the side of your driveway opposite the direction of the plow. If possible, try to clear an area next to the road, before your driveway. This will provide an area for the snow from the plow to pile up so it does not fall in your driveway.



*Note: Please do not shovel, snow blow, plow snow back into a plowed road. If it doesn't melt it turns to ice and creates a hazard for not only yourself but your neighbors and the public. A citation from the police could be given.

Yard Damage

Unfortunately, yard damage from the plows happens. It is never intentional but depending on the conditions it is hard to tell where the road stops and the grass starts. During the winter if possible, we will repair the yard the best we can, we may need to come back in the spring and add topsoil and seed if needed.

Mailbox Damage



Snow removal during the past few winter seasons was challenging to say the least. Although our staff did a tremendous job, it is not to say that there were not a few pitfalls. One such pitfall that occurs every winter season and was somewhat amplified this season was damage to residents' mailboxes. Our staff makes every effort to avoid such damage, however it does occasionally happen. More often than not, mailbox damage occurs when the heavy snow is discharged from the plow and strikes a mailbox. The deeper the snowfall, the more likely that will happen. It is very rare for the plow to actually strike the mailbox.

One might ask what can be done to avoid the damage. Relative to this topic is the trend in the use of plastic mailboxes. Our experience over the years is that plastic mailboxes, especially in the very cold weather, are not as durable as those made of metal or masonry. The Township certainly is not recommending one type of mailbox over the other but is trying to provide our residents with as much information as possible when making a decision on a new mailbox. We are doing so since it is the policy of the township to only provide a reimbursement, up to \$25, for those mailboxes actually struck by the truck or plow, with no reimbursement for damage from plow discharge. Hopefully this information will be helpful to our residents.

Safety Tips

Do not allow children to play in or near the streets any time during or after a winter storm. Children in forts or just standing along the road may not be visible to the plow operator or other vehicles. Also, do not allow anyone to throw snow or other objects at the plows or other vehicles as it may cause an accident.



ATV / Snowmobiles



It is mandatory for all ATV and snowmobile owners to register their vehicles. In addition, both ATV and snowmobile owners must carry liability insurance, except for those used solely on the owner's property for farming or business use. Please respect your neighbor's property and only ride on the lands in which you have permission to ride. Keep in mind that ATVs and snowmobiles are noisy and may be disturbing to your neighbors. Please respect those around you and operate these vehicles at reasonable hours.

Snow Emergency Ordinance #122

This ordinance makes it unlawful to park, or leave unattended, any vehicle anywhere along a street or highway within the Township; blow or deposit snow in or on any roadway within the Township during a declared Snow Emergency. Although this ordinance applies only during a declared Snow Emergency, the restrictions contained within the ordinance are to be adhered to during any winter storm. By doing so, it will allow the Public Works Department to expedite the task of snow removal and therefore, benefit the residents of Lower Nazareth Township.
