**A RESOLUTION OF THE BOARD OF SUPERVISORS OF  
THE TOWNSHIP OF LOWER NAZARETH,  
NORTHAMPTON COUNTY, COMMONWEALTH OF  
PENNSYLVANIA AUTHORIZING THE SUBMISSION OF A  
TRAFFIC SIGNAL MAINTENANCE AGREEMENT WITH  
PENNSYLVANIA DEPARTMENT OF TRANSPORTATION  
BY THE TOWNSHIP MANAGER**

**WHEREAS**, Lower Nazareth Township is a Second Class Township in the Commonwealth of Pennsylvania governed by the Second Class Township Code and the laws of the Commonwealth; and

**WHEREAS**, Lower Nazareth Township currently has an inventory of 23 traffic lights and it is feasible that more will be added in the future;


**WHEREAS**, the Board of Supervisors of Lower Nazareth Township desire to enter into a formal Traffic Signal Maintenance Agreement with the Pennsylvania Department of Transportation; and


**NOW, THEREFORE BE IT RESOLVED** by the authority of the Board of Supervisors of the Township of Lower Nazareth, Northampton County, and it is hereby resolved by authority of the same, that the Township Manager of Lower Nazareth Township be authorized and directed to submit the attached Traffic Signal Maintenance Agreement, to submit future modifications to the attached Traffic Signal Maintenance Agreement, and to submit future applications for Traffic Signal Approval either in writing or via electronic signature, to the Department of Transportation and to sign this Agreement on behalf of Lower Nazareth Township.
