**A RESOLUTION AUTHORIZING THE TOWNSHIP
MANAGER TO MAKE APPLICATION TO THE
TRAFFIC SIGNALS TECHNOLOGY GRANT ON
BEHALF OF LOWER NAZARETH TOWNSHIP
FOR THE PURPOSE OF PROVIDING FUNDING
FOR UPGRADING SIX TRAFFIC SIGNALS
ALONG ROUTE 248**

WHEREAS, the Board of Supervisors of Lower Nazareth Township recognizes their responsibilities to provide efficient and effective traffic flow for the protection of the health, safety and welfare of the public traversing on roads, whether local or state, within the Township; and

WHEREAS, the Route 248 corridor has been identified as a congested traffic corridor with six existing traffic signals located within Lower Nazareth Township; and

WHEREAS, it is the desire of the Board of Supervisors to authorize the Township Manager to apply for funding through the Traffic Signals Technology grant in the amount of \$445,800 for the upgrade of six traffic signals as defined in the proposal submitted by Carroll Engineering dated September 2022.

BE IT RESOLVED, that the Township of Lower Nazareth Township, Northampton County Pennsylvania hereby request a Traffic Signal Technologies grant of \$445,800 from the Commonwealth Financing Authority to be used for the purpose of upgrading six traffic lights on the Route 248 Corridor as follows:

Intersections will be upgraded with new ethernet switches, cabinet components, multi-directional FLIR Thermal detection, fiber optic cable connections, and Q-Free Advanced Traffic Management System (ATMS) software to connect to PennDOT's central control system.

BE IT FURTHER RESOLVED, that the Applicant does hereby designate Lori A. Stauffer, Township Manager as the official to execute all documents and agreements between Lower Nazareth Township, Northampton County, Pennsylvania and the Commonwealth Financing Authority to facilitate and assist in obtaining the requested grant.


