A RESOLUTION OF THE BOARD OF SUPERVISORS OF LOWER NAZARETH TOWNSHIP, NORTHAMPTON COUNTY, COMMONWEALTH OF PENNSYLVANIA ESTABLISHING A FEE SCHEDULE FOR SERVICE FEES FOR CERTIFICATION AS TO THE PAYMENT STATUS OF TAXES PREPARED BY THE TAX COLLECTOR'S OFFICE AND ESTABLISHING SERVICE CHARGE FEES FOR PROVISION OF DUPLICATE ORIGINAL TAX BILLS IN ACCORDANCE WITH SECTION I (B) AND (C) OF LOWER NAZARETH TOWNSHIP ORDINANCE NO. 223-02-18

WHEREAS, the Lower Nazareth Township Tax Collector is paid fees to perform services such as certifying payment status of taxes and production of duplicate tax bills; and

**WHEREAS**, the Board of Supervisors of Lower Nazareth adopted Ordinance No. 223-02-18, which established a fee schedule for these services; and

WHEREAS, Ordinance No. 223-02-18, Section 1(B) and 1(C) permits the Lower Nazareth Township Board of Supervisors to amend the fees charged for those services to be amended from time to time by resolution of the Township in the event the Township determines a need to change the initially authorized fee.

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of Supervisors of the Township of Lower Nazareth Township, Northampton County, Commonwealth of Pennsylvania by a majority vote at a duly advertised meeting of the Board of Supervisors on Wednesday, December 14, 2022, the fees for services rendered by the Township Tax Collector shall be amended as follows, effective January 1, 2023:

## SERVICE FEE REGARDING TAX CERTIFICATION

Lower Nazareth Township hereby authorizes the duly elected Township Tax Collector to impose a service fee of \$25.00 to be assessed to each person, firm or corporation requesting a certification as to the payment status of real estate taxes from the Lower Nazareth Township Tax Collector's office.

## SERVICE FEE FOR DUPLICATE ORIGINAL TAX BILL

Lower Nazareth Township hereby authorizes the duly elected Township Tax Collector to impose a service fee of \$15.00 to be assessed to each person, firm or corporation requesting a duplicate original tax bill.
