**A RESOLUTION OF THE BOARD OF SUPERVISORS OF
LOWER NAZARETH TOWNSHIP, NORTHAMPTON
COUNTY, COMMONWEALTH OF PENNSYLVANIA
APPOINTING CARROLL ENGINEERING AS SPECIAL
PROJECT ENGINEERING CONSULTANT FOR THE
NEWBURG PARK SPLASH PAD COMPLEX PROJECT**

WHEREAS, the Lower Nazareth Township Board of Supervisors believes one of the essential responsibilities of local government is to provide high-quality recreational amenities that provide their constituents with opportunities for entertainment, fitness, and connecting with other members of the community; and

WHEREAS, the Lower Nazareth Township Board of Supervisors has dedicated funding for the purposes of improving Township property known as Newburg Park; and

WHEREAS, the Lower Nazareth Township Board of Supervisors directed the Township Manager to apply for funding through the Department of Conservation and Natural Resources for the construction of a splash pad complex at Newburg Park; and

WHEREAS, the Department of Conservation and Natural Resources awarded Lower Nazareth Township a grant in the amount of \$200,000 for the construction of the Newburg Park Splash Pad Complex; and

WHEREAS, the project will require an engineering consultant due to the complex nature of the overall project; and


WHEREAS, the members of the Recreation Committee have recommended utilizing the engineering services of Carroll Engineering as an engineering consultant for the Newburg Park Splash Pad Complex.

NOW, THEREFORE BE IT RESOLVED, the Lower Nazareth Township Board of Supervisors appoints Carroll Engineering as the Special Project Engineer for the Newburg Splash Pad Complex utilizing the fee schedule submitted (Exhibit A).
