The Lower Nazareth Township Board of Supervisors held a hybrid meeting on Wednesday, June 21, 2023, Chairman James Pennington called the meeting to order at 7:04PM.

Northampton Farms, LLC (CU2023-03) - The proposed use is a warehouse, requiring Conditional Use approval as prescribed in the Lower Nazareth Township 2001 Zoning Ordinance, amended January 27, 2021; Article 11, Section 1103.A.8, Section 1105.B, and Section 1107. The property locations are 523 Nazareth Pike, Nazareth, PA, 18064, and 578 Daniels Road, Nazareth, PA, 18064, specifically Tax Map Parcel #K7-20-11 and K7-20-10. The properties are zoned Light Industrial Campus (LI).

Solicitor Asteak re-opened the hearing that originally began on May 11th.

Attorney Kaplin re-called witness, John McRoberts, Project Engineer with Pidcock. Residents had the opportunity to continue questioning the witness.

Attorney Kelleher, who represents numerous township residents, had an opportunity to cross-examine Mr. McRoberts. The Board of Supervisors, Mr. Kortze, and Solicitor Asteak questioned Mr. McRoberts.

The Board took a brief recess from 8:21pm – 8:31pm.

Attorney Kaplin called his next witness, Michael Derr, Geo-Technology Associates (GTA).


Solicitor Asteak opened public questions for Mr. Derr. Attorney Kelleher had an opportunity to cross-examine Mr. Derr. The Board of Supervisors and Solicitor Asteak questioned Mr. Derr.

Attorney Kaplin will wait to call his next witness, Christian Brown, Landscape Architect from Brown Design Corporation, until the next hearing date.

Solicitor Asteak closed for the evening at 9:21 pm. The hearing will resume on July 13th at 7pm.
