**A RESOLUTION AUTHORIZING THE TOWNSHIP  
MANAGER TO MAKE APPLICATION TO THE  
MULTI-MODAL TRANSPORTATION GRANT  
PROGRAM ON BEHALF OF LOWER NAZARETH  
TOWNSHIP FOR THE PURPOSE OF PROVIDING  
FUNDING FOR THE REALIGNMENT OF  
BUTZTOWN ROAD INTERSECTION AND  
REHABILITATION OF BUTZTOWN ROAD**

**WHEREAS**, Lower Nazareth Township is a community consisting of approximately eight square miles with a population of 6,922 people; and

**WHEREAS**, the Board of Supervisors of Lower Nazareth Township recognizes their responsibilities under the Second Class Township Code to provide proper infrastructure for the public's health, safety and welfare; and

**WHEREAS**, Butztown Road is a Township road owned by Lower Nazareth Township; and

**WHEREAS**, the intersection of Butztown Road and State Route 191 is currently unsafe and the Lower Nazareth Township Board of Supervisors desires to realign the intersection to maximize the public's safety; and

**WHEREAS**, the overall condition of Butztown Road and the stormwater pipes serving the road are deteriorating; therefore, the Lower Nazareth Township Board of Supervisors desires to rehabilitate Butztown Road.

**BE IT RESOLVED**, that the Lower Nazareth Township, Northampton County Pennsylvania hereby requests a Multimodal Transportation Fund grant of \$819,103, from the Commonwealth Financing Authority to be used for the purpose of rehabilitating Butztown Road and realigning the intersection with State Route 191.

**BE IT FURTHER RESOLVED**, that the Applicant does hereby designate Lori A. Stauffer, Township Manager as the official to execute all documents and agreements between Lower Nazareth Township, Northampton County, Pennsylvania and the Commonwealth Financing Authority to facilitate and assist in obtaining the requested grant.
