## LOWER NAZARETH TOWNSHIP NOTICE OF ZONING HEARING BOARD MEETING

Public Notice by the Lower Nazareth Township Zoning Hearing Board is hereby given for a Zoning Hearing meeting to be held on Tuesday, July 25, 2023, at 6:30 p.m., in the Lower Nazareth Township Municipal Building, 623 Municipal Drive, Nazareth, PA, 18064 regarding the following zoning appeals from the Lower Nazareth Township 2001 Zoning Ordinance, last amended February 8, 2023:

**592 Nazareth Pike, LLC** (**ZA2023-12**) – The applicant is seeking a variance to operate more than one use per lot pursuant to Article 14, Section 1401; Special Exception approval for outdoor storage pursuant to Article 9, Section 903.C; a variance from Article 15, Section 1502.A.8, Additional Requirements for an Auto Repair Garage; and a variance from Article 1, Section 109.A.2.(a).1, Zoning Permit requirements. The property location is 592 Nazareth Pike, Nazareth, PA 18064, specifically Tax Map #K7-21-2B, and is zoned General Commercial (GC).

**Greg Properties, LLC** (**ZA2023-13**) – The applicant is seeking variances from Article 18, Section 1817.A.5, Freestanding Sign, and Section 1817.A.4, Wall Signs. The property location is 3830 Easton-Nazareth Hwy, Easton, PA, 18045, specifically Tax Map #K8-10-7A, and is zoned Planned Industrial-Commercial (PIC).

Constantine and Kathleen Yialamas (ZA2023-14) — The applicant is seeking Special Exception approval for a home occupation to operate a salon pursuant to Article 5, Section 503.A, and Article 15, Section 1503.F.8.(g). The property location is 4483 Oakwood Lane, Nazareth, PA, 18064, specifically Tax Map #L7-5-7G-24, and is zoned Low Density Residential (LDR).
