A RESOLUTION AUTHORIZING THE TOWNSHIP MANAGER TO MAKE APPLICATION TO THE STATEWIDE LOCAL SHARE ACCOUNT ON BEHALF OF LOWER NAZARETH TOWNSHIP FOR THE PURPOSE OF PROVIDING FUNDING FOR TRAINING EQUIPMENT FOR THE HECKTOWN VOLUNTEER FIRE COMPANY

WHEREAS, the Board of Supervisors of Lower Nazareth Township recognizes their responsibilities under the Second Class Township Code to provide fire protection to the constituents of the Township in order to protect their health, safety and welfare; and

WHEREAS, the Hecktown Volunteer Fire Company was established by a group of volunteers in 1917 and they have consistently served the Township of Lower Nazareth by providing emergency protection services; and

WHEREAS, in order to provide basic emergency and fire protection services for the community, the volunteers of the Hecktown Volunteer Fire Department engage in thousands of hours of training, which promotes the protection and safety of the volunteers in the performance of their duties; and

WHEREAS, in order to provide maximum training potential, the use of certain pieces of equipment enhance the skills of our firefighters; and

BE IT RESOLVED, that the Lower Nazareth Township, Northampton County Pennsylvania hereby request a Statewide Local Share Account grant of \$83,950.00 from the Commonwealth Financing Authority to be used for the purpose of purchasing training equipment for Hecktown Volunteer Fire Company.

BE IT FURTHER RESOLVED, that the Applicant does hereby designate Lori A. Stauffer, Township Manager as the official to execute all documents and agreements between Lower Nazareth Township, Northampton County, Pennsylvania and the Commonwealth Financing Authority to facilitate and assist in obtaining the requested grant.
