A RESOLUTION AUTHORIZING THE TOWNSHIP MANAGER TO MAKE APPLICATION TO THE STATEWIDE LOCAL SHARE ACCOUNT ON BEHALF OF LOWER NAZARETH TOWNSHIP FOR THE PURPOSE OF PROVIDING FUNDING FOR A CARDIAC MONITOR FOR BETHLEHEM TOWNSHIP VOLUNTEER FIRE COMPANY

WHEREAS, Lower Nazareth Township is a community consisting of approximately eight square miles with a population of 6,922 people; and

WHEREAS, the Board of Supervisors of Lower Nazareth Township recognizes their responsibilities under the Second Class Township Code to provide basic life support and advanced life support to the constituents of the Township in order to protect their health, safety and welfare; and

WHEREAS, the Board of Supervisors entered into an agreement with Bethlehem Township Volunteer Fire Company to provide these services to the constituents of Lower Nazareth Township, which includes providing an annual stipend and the use of a building owned by the Township for the ambulance operations; and

WHEREAS, it is the primary goal of Bethlehem Township Volunteer Fire Company to provide optimal care for their patients during the course of transit to the hospital; and

WHEREAS, in order to provide optimal care, basic pieces of equipment, including a cardiac monitor are required on each transport unit.

BE IT RESOLVED, that the Lower Nazareth Township, Northampton County Pennsylvania hereby request a Statewide Local Share Account grant of \$41,860.00 from the Commonwealth Financing Authority to be used for the purpose of purchasing a Cardiac Monitor for Bethlehem Township Volunteer Fire Company.

BE IT FURTHER RESOLVED, that the Applicant does hereby designate Lori A. Stauffer, Township Manager as the official to execute all documents and agreements between Lower Nazareth Township, Northampton County, Pennsylvania and the Commonwealth Financing Authority to facilitate and assist in obtaining the requested grant.
