WAIVER/RELEASE FOR COMMUNICABLE DISEASES INCLUDING COVID-19 ASSUMPTION OF RISK / WAIVER OF LIABILITY / INDEMNIFICATION AGREEMENT in consideration of being allowed to participate in LOWER NAZARETH TOWNSHIP SUMMER PARK PROGRAM and related events and activities (INCLUDING DAYS THAT SUMMER PARK IS HELD AT NEWBURG PARK SPLASH PARK), the undersigned acknowledges, appreciates and agrees that: 1. Participation includes possible exposure to and illness from infectious diseases including but not limited to MRSA, influenza, and COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist; and, 2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and, 3. I willingly agree to comply with the stated and customary terms and conditions for participation as regards protection against infectious diseases. If, however, I observe any unusual or significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and, 4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS LOWER NAZARETH TOWNSHIP SUMMER PARK PROGRAM, their officers, organizations, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("RELEASEES"), WITH RESPECT TO ANY AND ALL ILLNESS, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF RELEASEES OR OTHERWISE, to the fullest extent permitted by law. I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IF FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT FOR PARTICIPANTS OF MINOR AGE (UNDER AGE 18 AT THE TIME OF REGISTRATION). 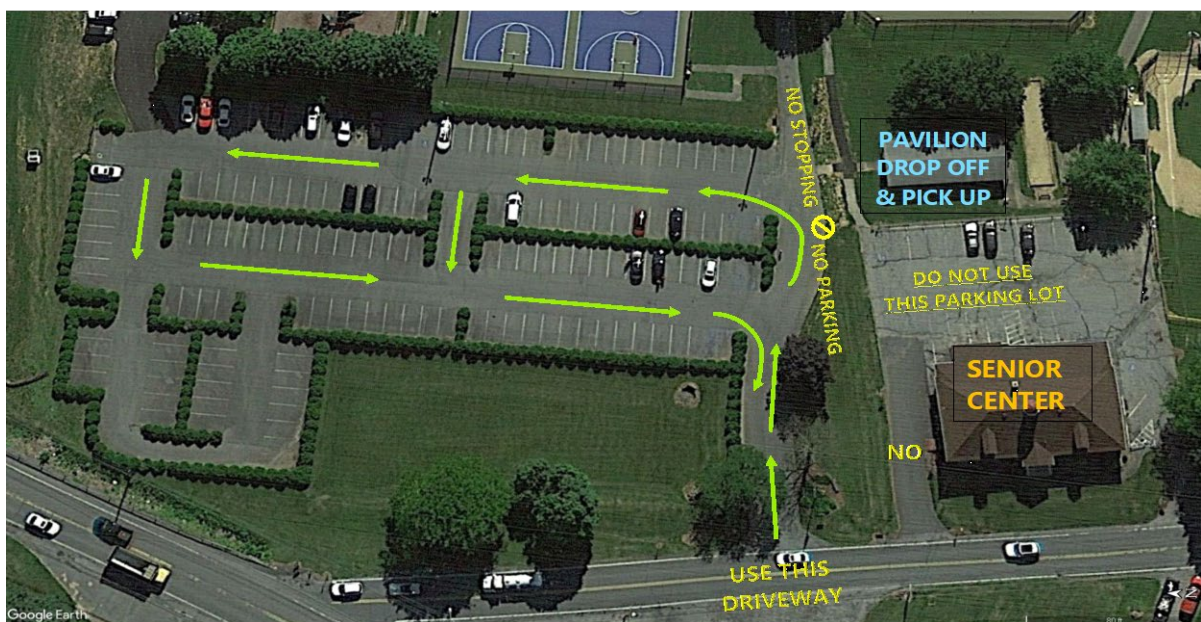
Dear Parents (Guardians) and Campers:

Welcome to the Lower Nazareth Township Summer Park Program. The staff has put a great deal of time and effort into planning another exciting and enjoyable summer. For the program to be a success we have implemented the policies listed below. Please thoroughly review the guidelines and sign on the back if you agree with the terms.

PARKING & DROP OFF PROCEDURE

- **The Township Building Parking Lot (smaller lot between township building and pavilion) is being utilized by the Senior Center. VERY IMPORTANT: NO PARKING - DURING DROP OFF or PICK UP is permitted from this lot. The Senior Center opens at 9 AM with seniors arriving to park in the smaller lot behind the Senior Center. For everyone’s safety please park your car in a parking space in the larger lot when dropping off/retrieving your campers. You would then have to walk the campers over the pavilion to sign them in. To help with safety and traffic issues, we have also implemented a one-way policy in the large parking lot (see below graphic).**
- Campers must sign-in with the leaders upon arrival. **Campers may not be dropped off prior to 9:00 am and should arrive not later than 9:30 am.** Campers will receive a wristband to wear while participating in the program.
- Every camper must be retrieved by a parent/guardian or authorized person. Campers are not permitted to leave the park on their own. Please make sure you have listed the individuals that will be your “authorized person” who will be dropping off or picking up your campers on the registration form.
- Campers are to be signed out with their leaders and return the wristband each day. **Campers need to be picked up promptly at the end of each session. Late pick-ups will not be tolerated. After ONE late pick-up, the campers not picked up on time may be dropped from the program with NO REFUND.**

PARTICIPANT & PARENTAL BEHAVIOR

For us to operate an efficient and organized program, it is necessary for the staff to maintain control of the campers during our activities. It is your responsibility to discuss with your children his/her behavior while attending the program.

- Disruptive, abusive behavior, foul language, and rude behavior by campers and/or parents towards the Program Director, Program Leaders, Township Staff, Program Visitors will not be tolerated.
- No cell phones or electronic devices. Parents can get a message to campers through the Park Coordinator.
- Do not climb trees or on the rock.
- Do not throw sticks, stones, or dirt.
- Keep the park clean – Pick up your trash.
- No fighting, bullying or threatening words – If you have a problem, walk away and tell a Program Leader.
- Disciplinary action will be given when applicable. There is a three (3) strike policy – (1st offense) verbal, (2nd offense) written and parent/guardian spoken to, and (3rd offense) suspension. Fourth offense, camper will be terminated from the program without a refund.

HELPFUL TIPS TO ENSURE HEALTH & SAFETY

- Campers should bring a water bottle with their name on it.
- Please feel free to pack a snack (NUT FREE!!) Numerous children participating in our program have food allergies. **Please check the ingredients list on all food labels to be sure!**
- Please label your camper's belongings with first & last name.
- Please apply sunscreen prior to coming to park especially on Splash Park Days.
- Campers should wear sneakers (no sandals or flip-flops)
- Campers are allowed to wear croc footwear for water day events such as Hero Day (fire trucks spraying water for the children to run under), Water Balloon Day or Splash Park Days as long as they have at least a strap over the heel.

WEATHER CANCELLATIONS

We have limited our program so that we fit within the capacity limits of the township building at the park if raining. Since we have drop off and pick up under the pavilion if any severe weather or lightning current or forecasted, camp may be cancelled since we have to walk the campers back and forth between the pavilion and township building. We have a large tv with movies, games and crafts for the campers while in the building. Campers may get wet or muddy if the rain clears and they are allowed out in the park. Feel free to keep your campers home on any day with inclement weather if you do not like this setup and/or activities. We were trying to give parents/guardians an option with rainy weather.

- In the event of inclement weather with an unfavorable forecast prior to 9:00 am, the program will be cancelled. **This decision will be made approximately (1) one hour prior to the scheduled start time and will be based upon current weather conditions, facility conditions, and weather forecasts.**



- If we experience bad weather between 9:00 am and 12:00 pm, the children will be moved to the township building to play games, crafts and watch movies until park is over. Obviously, if the weather conditions are expected to get worse, we will cancel park and encourage parent/guardian or authorized person to retrieve the campers as soon as possible.
- In both situations we will send out a mass text message to parents/guardians. **You will need to notify your authorized person to pick up or drop off your children for that given day of cancellation.**

SPLASH PARK DAYS – Park is more likely to be cancelled on these days depending on weather or forecast. If park has already started and unexpected inclement weather happens, the campers will be taken to the pavilion next to the Splash Park and a text message that park is cancelled will be sent out and that we need for parent/guardian or authorized person to retrieve the campers as soon as possible.
