- Operator’s Business Permit
- Current Vehicle Registration
- Motor Vehicle Insurance

License Limitations and Requirements

1. Each INDIVIDUAL intending to peddle or solicit for/on behalf of any legal entity shall make a personal application for such license. An individual license shall be required for each individual engaged in peddling or soliciting in Lower Nazareth Township.
2. This license is not transferable from one vendor to another vendor.
3. The issuance of a mobile food service permit does not create a real estate interest in any permitted space as a leasehold or otherwise, and the holder of the food vending permit shall be construed as a licensee.
4. Hours of operation are limited to 8:00 a.m. to 9:00 p.m. daily EST, unless otherwise restricted by the operator’s mobile food vendor permit or by the property owner.
4. Lower Nazareth Township may suspend any license issued under this ordinance #251-06-24 where there is a violation of any provisions of this ordinance.
5. A mobile food vendor permit authorizes the holder to engage in the vending of products from a mobile food service vehicle in compliance with this Code and as specified on the permit. The mobile food vendor permit must be prominently displayed when the mobile food service vehicle is in operation.
6. The license expires (365) days from the date of issuance. Each new interval period constitutes a new license application and fee.

I acknowledge that I have read the applicable rules outlined in Ordinance #251-06-24 and will comply with all applicable requirements herein. I also understand and acknowledge that failure to comply with these limitations and regulations and any other Lower Nazareth Township Ordinance shall be grounds for immediate revocation of this license. Furthermore, in making this application I indemnify, defend, and hold harmless Lower Nazareth Township from all claims, liabilities, obligations, damages, penalties, costs, and expenses, including reasonable attorney fees and disbursements of any kind or nature, including, but not limited to, actions for personal injury or death, or the assessment of fines or penalties by any governmental agency.
