License Limitations and Requirements

By signing below, the Applicant is affirming their understanding of the following:

1. Each INDIVIDUAL intending to peddle or solicit for/on behalf of any legal entity shall make a personal application for such license. An individual license shall be required for each individual engaged in peddling or soliciting in Lower Nazareth Township.
2. This license is not transferable from one person to another person.
3. Hours of operation are limited to 9:00 a.m. to 7:00 p.m. EST, Monday through Saturday. No peddling is permitted on Sunday or legal holidays.
4. No person licensed as a Peddler under Ordinance #251-06-24 shall occupy any fixed location upon any of the streets, alleys or sidewalks of the township for the purpose of peddling, with or without any stand or counter.
5. Lower Nazareth Township may suspend any license issued under this ordinance #251-06-24 where there is a violation of any provisions of this ordinance.
6. Peddlers must carry the license upon their person. All Transient Retail Merchants shall exhibit such license upon request to all police officers, township officials and citizens. No person shall engage in selling products or services not mentioned upon such license.
7. Transient Retail Merchants must display their goods in commercially zoned areas and cannot impede traffic flow, sight distances, parking or be in violation of any other township ordinance.
8. The license expires (30) days from the date of issuance. The license may be renewed in 30-day intervals for a period no longer than 180 days after the first issuance. Each new interval period constitutes a new license application and fee.

I have read the above license limitations and regulations and agree to comply with these limitations and regulations and with all other Lower Nazareth Township Ordinances including but not limited to Ordinance #251-06-24. I also understand and acknowledge that failure to comply with these limitations and regulations and any other Lower Nazareth Township Ordinance shall be grounds for immediate revocation of this license. Furthermore, I verify that the facts set forth in this application are true to the best of their knowledge, information and belief. This verification is made subject to the penalties of the Pennsylvania Crimes Code (18 PA C.S.A. Section 4904) relating to unsworn falsification to municipal authorities.
