**A RESOLUTION AUTHORIZING THE TOWNSHIP
MANAGER TO MAKE APPLICATION TO THE
MONROE COUNTY LOCAL SHARE ACCOUNT
ON BEHALF OF LOWER NAZARETH TOWNSHIP
FOR THE PURPOSE OF PROVIDING FUNDING
FOR A DECONTAMINATION WASHER AND
DRYER FOR THE HECKTOWN VOLUNTEER
FIRE COMPANY**

WHEREAS, Lower Nazareth Township is a community consisting of approximately eight square miles with a population of 6,922 people; and

WHEREAS, the Board of Supervisors of Lower Nazareth Township recognizes their responsibilities under the Second Class Township Code to provide fire protection to the constituents of the Township in order to protect their health, safety and welfare; and

WHEREAS, the Hecktown Volunteer Fire Company was established by a group of volunteers in 1917 and they have consistently served the Township of Lower Nazareth by providing emergency protection services; and

WHEREAS, in order to provide basic emergency and fire protection services for the community, the volunteers of the Hecktown Volunteer Fire Department require certain equipment, which promotes the protection and safety of the volunteers in the performance of their duties; and

BE IT RESOLVED, that the Lower Nazareth Township, Northampton County Pennsylvania hereby request a Monroe County Local Share Account grant of \$48,220.00 from the Commonwealth Financing Authority to be used for the purpose of purchasing a decontamination washer and dryer for Hecktown Volunteer Fire Company.


