**A RESOLUTION AUTHORIZING THE TOWNSHIP
MANAGER TO MAKE APPLICATION TO THE
STATEWIDE LOCAL SHARE ACCOUNT ON
BEHALF OF LOWER NAZARETH TOWNSHIP
FOR THE PURPOSE OF PURCHASING A STREET
SWEEPER**

WHEREAS, Lower Nazareth Township is a community consisting of approximately eight square miles with a population of 6,922 people; and

WHEREAS, the Board of Supervisors of Lower Nazareth Township recognizes their responsibilities under the Second Class Township Code to provide safe and clean street to the constituents of the Township in order to protect their health, safety and welfare; and

WHEREAS, the Lower Nazareth Township Public Works Department has established a street cleaning program that promotes the safe travel and promotes the goals of the Department of Environmental Protection and the MS-4 program; and

WHEREAS, in order to continue providing street sweeping for the community, the Public Works Department requires certain equipment, including a well-functioning street sweeper, which clears debris and stones from the roads of the Township; and


BE IT RESOLVED, that Lower Nazareth Township, Northampton County Pennsylvania hereby requests a Statewide Local Share Account grant of \$387,153 from the Commonwealth Financing Authority to be used for the purpose of purchasing a new street sweeper.


BE IT FURTHER RESOLVED, that the Applicant does hereby designate Lori A. Stauffer, Township Manager as the official to execute all documents and agreements between Lower Nazareth Township, Northampton County, Pennsylvania and the Commonwealth Financing Authority to facilitate and assist in obtaining the requested grant.


