A RESOLUTION AUTHORIZING THE TOWNSHIP MANAGER TO MAKE APPLICATION TO THE NORTHAMPTON LEHIGH COUNTIES LOCAL SHARE ACCOUNT ON BEHALF OF LOWER NAZARETH TOWNSHIP FOR THE PURPOSE OF PURCHASING A CARDIAC MONITOR FOR BETHLEHEM TOWNSHIP VOLUNTEER FIRE COMPANY

WHEREAS, Lower Nazareth Township is a community consisting of approximately eight square miles with a population of 6,922 people; and

WHEREAS, the Board of Supervisors of Lower Nazareth Township recognizes their responsibilities under the Second-Class Township Code to provide emergency services such as basic life support and advanced life support in the community; and

WHEREAS, Bethlehem Township Volunteer Fire Company provides basic life support and advanced life support emergency services for Lower Nazareth Township; and

WHEREAS, Bethlehem Township Volunteer Fire Company has a substation located on Hanoverville Road in Lower Nazareth Township; and

WHEREAS, in an effort to provide life saving care, the paramedics must utilize basic equipment such as a cardiac monitor and that equipment must be in good working condition.

BE IT RESOLVED, that the Lower Nazareth Township, Northampton County Pennsylvania hereby request a Northampton Lehigh Counties Local Share Account grant of \$63,556 from the Commonwealth Financing Authority to be used for the purpose of purchasing a LifePak 35 Cardiac Monitor for the use by Bethlehem Township Volunteer Fire Company as they serve the residents of Lower Nazareth Township.

BE IT FURTHER RESOLVED, that the Applicant does hereby designate Lori A. Stauffer, Township Manager as the official to execute all documents and agreements between Lower Nazareth Township, Northampton County, Pennsylvania and the Commonwealth Financing Authority to facilitate and assist in obtaining the requested grant.
