Agenda Amendment and Approval

N. Teague made a motion to approve the agenda. S. Brown seconded. Motion passed (4-0).

Approval of Minutes

The meeting minutes of August 27th were submitted for review and approval. A. Templeton made a motion to approve the minutes. S. Brown seconded. Motion passed (4-0).

Supervisor's Comments

<u>Open Space Preservation</u> – S. Brown reported the EAC met and was working on revising their evaluation forms. Additionally, a member of the public attending the meeting made some recommendations for the Subdivision and Land Development Ordinance update that Supervisor Brown forwarded to the Planning Commission.

<u>Parks and Recreation</u> – A. Templeton announced that Dog's Day Out is coming up on Saturday, September 13th. The event has some great food trucks as well as a lot of vendors. It should be a great day.

Library News – Nothing new to report.

CRPC – J. Pennington reported on the most recent meeting with Colonial Regional Police Commission.

Board of Supervisors Minutes September 10, 2025 <u>Eagle Scout Presentation</u> – Michael Lucas of Troop 76 appeared to discuss his proposed Eagle Scout project to the Board. Michael is proposing to construct a picnic and grill area with a firepit and benches at the building at 4519 Hanoverville Road. He reviewed his project parameters. He requested the Township Public Works to remove the old stone. No permit is required

N. Teague made a motion to approve the Eagle Scout project as presented. S. Brown seconded. Motion passed (4-0).

Subdivision & Land Development

<u>Subdivision and Land Development Ordinance Update Presentation</u> – A. Schwartz of Environmental Planning & Design appeared to discuss with the Board the progress of the Subdivision and Land Development Ordinance update. He reviewed how the reorganization of the document will help improve the flow of the processes that the ordinance governs. N. Teague stated she loves the flow chart.

G. Asteak stated the LVPC will be requiring all applications to be submitted electronically in the future.

Solicitor's Report -

<u>Borrowing Ordinance</u> – G. Asteak stated PennDOT is requiring a letter of credit for the Butztown Road project. As part of issuing the letter of credit, the Township needs to apply to DCED under the Local Government Unit Debt Act, which includes the adoption of an ordinance. N. Teague made a motion to adopt Ordinance #256-09-25. A. Templeton seconded. Motion passed (4-0).

<u>Nuisance Ordinance</u> – The ordinance will need to be advertised for a future meeting. The newspaper failed to run the advertisement.

<u>Volunteer Firefighter Real Estate Tax Credit Ordinance</u> – G. Asteak provided the Board with a draft ordinance for their review. He stated he has been working with L. Stauffer to prepare the draft; however, he would like to have L. Stauffer and T. Dravecz to review the outlined procedure before advertisement. N. Teague made a motion to authorize the solicitor to advertise the proposed ordinance. A. Templeton seconded. Motion passed (4-0).

Engineer's Report

J. Coyle reported the Butztown Road work will commence next Monday.

Manager's Report

<u>Joint Purchasing Cooperative</u> – Northampton County is initiating a cooperative purchasing group for janitorial supplies. If Lower Nazareth wishes to join, now is the time to do so; however, joining the cooperative does not obligate the Township to participate. S. Brown made a motion to join the Northampton County Joint Purchasing Cooperative for janitorial supplies. A. Templeton seconded. Motion passed (4-0).

<u>BTVFC</u> Request for Grants – L. Stauffer reported she has received a request from BTVFC, our ambulance provider, to submit three grant applications for a cardiac monitor, carbon monoxide detectors, and portable radios on their behalf. The grants would be submitted through the Northampton Lehigh LSA program and the Monroe County LSA program. N. Teague made a motion to authorize the submission of the requested grants. A. Templeton seconded. Motion passed (4-0).

L. Stauffer stated she will have the necessary six resolutions ready for the next meeting.

<u>2025 Upset Sale</u> – L. Stauffer reported she has provided the Board with the 2025 Northampton County Upset sale list for their information.

Payment of the Bills

N. Teague made a motion to pay the bills as presented. S. Brown seconded. Motion passed (4-0).

Courtesy of the Floor

Dave Halteman of 4065 Hecktown Road inquired if any decisions or movements have been made regarding lot size in the Agricultural zoning district. N. Teague responded the Board is exploring its different options that will provide a balance.

Sherri Bourneuf of 4682 Stafford Ave stated she is aware of the data breach and inquired if people who were affected were sent notices. L. Stauffer replied that notices were sent to those individuals affected.
